WHEREAS, the recognition was granted to the institution namely Prameswari College of Education (D.Ed.), Kalavarai Village, Bobbili Mandal, Viziamagaram District-535558, Andhra Pradesh run by Uma General Technical & Medical Educational Society, Vizianagaram District, Andhra Pradesh. The SRC vide order F.SRO/NCTE/SRCAPP14471/D.El.Ed.-Al/AP/2016-2017/83716 dt.11.04.2016 for conducting (B.Ed.) course of two-year duration from the academic session 2016-17 with an annual intake of 100 students & the SRC vide order F.SRO/NCTE/D.Ed./2007-2008 dt.17.04.2008 for conducting (B.Ed.) course of two-year duration from the academic session 2007-08 with an annual intake of 50 students.

- 2. AND WHEREAS, a letter was received from the institution vide dated 16.10.2017 for reduction of intake from 2 units to 1 unit of D.El.Ed.-Al programme from the academic year 2018-2019.
- 3. AND WHEREAS, the SRC in its 349<sup>th</sup> meeting held on 15-16 December 2017 and the Committee decided as under: -
  - 1. This is a request for reduction from B.Ed. (2 units) to B.Ed. (1 unit).
  - We have prescribed certain formalities to be completed before such a request can be entertained.
  - 3. See that such cases are always put up when all formalities have been completed.
- 4. AND WHEREAS, the SRC in its 352<sup>nd</sup> meeting held on 04-05 January 2018 and the Committee decided as under: -
  - Our decision dated 15-16 December 2017 about reduction of the intake- strength wrongly referred to the course as B.Ed. when it should have been D.El.Ed.-Al.
  - The mistake is acknowledged. The decision is reviewed and corrected to read "D.El.Ed.-Al".
  - SRO has already issued an order corrected accordingly.
  - The action taken by SRO is ratified.

A letter dated 29.10.2020 was received from the institution.

5. AND WHEREAS, the matter was further considered by the SRC in its 392<sup>nd</sup> meeting held on December 15-16, 2020 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to withdraw the recognition granted to Prameswari College of Education (D.Ed.), Kalavarai Village, Bobbili Mandal, Viziamagaram District-535558, Andhra Pradesh for conducting D.El.Ed, D.El.Ed-Al courses under clause 17(1) of NCTE Act, 1993 on its own request by the institution. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course.
- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Prameswari College of Education (D.Ed.), Kalavarai Village, Bobbili Mandal, Viziamagaram District-535558, Andhra Pradesh run by Uma General Technical & Medical Educational Society, Vizianagaram District, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 150 students w.e.f. the next academic session.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website

www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
