WHEREAS, the recognition was granted to the institution namely Miriam College of Education, Paramjyoti Public School Campus, Amalapuram-533201, E.G. Dt., Andhra Pradesh run by A Christian Minority Educational Institution, Amlapuram-533201, East SRC District. Andhra Pradesh. The Godavari F.AP/B.Ed/New/57/SRO/NCTE/2000-2001/6066 dt. 15.03.2001 for conducting (B.Ed.) course of two-year duration from the academic session 2000-01 with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 02.02.2015. A Revised Provisional Recognition Order was issued to the institution on 14.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, a corrigendum no. SRO/NCTE/AOS00324/B.Ed/AP/2017-3. 18/94092 dated 21.07.2017 was issued to the institution for conducting B.Ed. programme of two year duration with an annual intake of 50 for one basic unit of 50 students.
- AND WHEREAS, the SRC in its 343rd meeting held on 01st to 02nd August, 2017 considered the matter and decided as under:-
 - These are RPRO cases. In view of the latest instructions, no inspection is required in these.
 - But, these also involve 'shifting'. Therefore, VT Inspection will be required.
 - The SRO's request is noted and permission is given for organizing VT Inspections in these cases.
- AND WHEREAS, as per the direction of SRC, the inspection of the institution was 5. conducted on 31.10.2017 to 02.11.2017 VT Report received in office of SRC on 06.11.2017.
- AND WHEREAS, The SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 6. considered the matter and decided to issue Final SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a First Show Cause Notice was issued to the institution on 20.11.2019. The institution has did not submit Show Cause Notice reply.

- **7. AND WHEREAS,** the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 and 387th meeting held on 24th & 25th August, 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Report accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, Final Show Cause Notice was issued on **07.09.2020**. The institution has submitted on 19.09.2020 submitted its reply to the Final Show Cause Notice.
- 8. AND WHEREAS, the institution has submitted on 19.09.2020 submitted its reply to the Final Show Cause Notice as under:-
- "..Herewith I brought this to your kind notice that the shifting the premise to owned for this we submitted the affidavit and other necessary documents and also paid 1,50000/- on July, 2015 for **Application and Processing Fee** as asked by NCTE, then two officials from NCTE visited namely Dr. Nishi Aggarwal, Cell No. 9457172537 and Dr. Madhu Chaturavedi, Cell No. 961055121. They physically verified all the necessary documents and premises on 31.10.2017 and 01.11.2017. We hope that they have submitted the same to you.

Since that period we haven't received any conformation letter from you. Institution of that recently we have received show case notice regarding this.

Hence I request you to consider the previous inspection which was visited on 03.10.2017 and issue change of premises certificate.

I herewith enclosed e-mail conversion of your team before inspection and after inspection our institution.

9. AND WHEREAS, the matter was further considered by the SRC in its 393^{rd} meeting held on January $5^{th} - 6^{th}$, 2021 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution and the Committee found the following deficiencies in the representation submitted by the institution: -

- 1. The institution has submitted a faculty list which is not approved by the Affiliating body. Some deficiencies are:
 - i. A letter regarding approval of faculty issued by the affiliating body has not submitted by the institution.
 - ii. The institution has not appointed Performing Arts faculty.
- 2. The institution has submitted photocopy of building plan but not readable.
- 3. The institution has submitted photocopy of BCC but not approved by competent authority.
- 4. The institution has not submitted a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs

Hence, the Committee decided to withdraw the recognition granted to Miriam College of Education, Paramjyoti Public School Campus, Amalapuram-533201, E.G. Dt., Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 10. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Miriam College of Education, Paramjyoti Public School Campus, Amalapuram-533201, E.G. Dt., Andhra Pradesh run by A Christian Minority Educational Institution, Amlapuram-533201, East Godavari District, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.
- 11. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

12. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
