WHEREAS, the recognition was granted to the institution namely, Kondapally Pydithalli Naidu College of Education, Vizianagaram, Revenue Division, Gantvada, Vizianagaram district-535215, Andhra Pradesh run by Pydithallamma Vydya Vignana Society, Srinivasa Nilyam Near St. Joshes School Cantonment Vizianagaram-535215, Andhra Pradesh. The SRC vide order F.AP/ NEW/B.Ed/179/SRO/NCTE/2002-2003/6671 dt. 09.04.2003 for conducting (B.Ed.) course of two-year duration from the academic session 2002-03 with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by 2. consented to come under new Regulations vide a notarized affidavit dated 30.01.2015. A Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, the matter was placed before in SRC 314th meeting held on 27th & 28thMay, 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on 14.06.2016. Inspection of the institution has not been conducted till date.
- AND WHEREAS, the institution submitted written representation on 27.09.2016 requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. Accordingly, order for reduction of strength from 2 units to 1 unit issued on 21.07.2017.
- AND WHEREAS, the SCN/FSCN was considered by the sub-Committee constituted by the SRC in its meeting held on 22nd Oct., 2019.the Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. Accordingly, a First Show Cause Notice was issued on 24-10-2019. The institutions vide letter dated 11.11.2019 submitted reply to the First Show Cause Notice along with
- AND WHEREAS, The SRC in its 384th meeting held on 12th -13th February, 2020 decided as under:-
 - The institution is required to submit certified copy of registered land duly approved by the competent govt. authority.
 - Notarised copy of the Building Completion Certificate issued by the (ii) competent govt. authority.
 - The institution is required to submit translated version of latest NEC duly (iii) approved by the competent authority.

- (iv) The institution is required to submit original blue-prints of building plan duly approved by the competent authority.
- (v) The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)
- (vi) The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice.

Accordingly, a Final Show Cause Notice was issued to the institution on **26-02-2020**. The institutions vide letter dated **05.03.2020** submitted reply to the First Show Cause Notice along with documents.

5. AND WHEREAS, the matter was further considered by the SRC in its 393^{rd} meeting held on January $5^{th} - 6^{th}$, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the representation submitted by the institution in response to the Final Show Cause Notice issued to the institution, and the Committee found the following deficiencies: -

- 1. The institution has submitted copy of Building plan in which multipurpose hall size is not mentioned.
- 2. The institution is required to submit a Letter regarding approval of faculty issued by the affiliating body submitted.
 - (i) The Principal does not have NET/Ph.D. as per NCTE Recognition.
 - (ii) 3 Assistant Professor does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.
 - (iii) The institution has not appointed the faculty of Performing Arts.
- 3. The institution has submitted photocopy of FDRs Rs.7Lakhs and 5Lakhs.
 - (i) FDR No. 013340 Rs.7 Lakhs is matured on 30.05.2020.
 - (ii) FDR No. 013341 Rs.5 Lakhs is matured on 30.05.2020.
- 4. The institution has not submitted a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.

Hence, the Committee decided to withdraw the recognition granted to Kondapally Pydithalli Naidu College of Education, Vizianagaram, Revenue Division, Gantvada, Vizianagaram district-535215, Andhra Pradesh for conducting B.Ed, course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Kondapally Pydithalli Naidu College of Education, Vizianagaram, Revenue Division, Gantvada, Vizianagaram district-535215, Andhra Pradesh run by Pydithallamma Vydya Vignana Society, Srinivasa Nilyam Near St. Joshes School Cantonment Vizianagaram-535215, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
