**WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely **Sri Sainath College of Education, Sri Shiridi Sainath Education, Ac./o.k.m.d Axmathulla, H.No.1, Channambatti Street, Yemmiganur, Kurnool District – 518360, Andhra Pradesh** run by **Sri Shiridi Sainath Educational Society, Vinayak, Nagar, RTC colony, Hayat Nagar, Hyderabad, Rangareddy District, Telangana.** The SRC vide order F.No.APS06270/B.Ed/Ap/2012/45743 dt. 03.09.2012 for conducting (B.Ed.) course of two-year duration from the academic session 2007-08 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated **22.01.2015**. A Revised Provisional Recognition Order was issued to the institution on 30.06.2015 for conducting **B.Ed. course** of two years duration with an annual intake of **100 students (two units)** from the academic session 2015-2016.

3. **AND WHEREAS**, the matter was placed before the Southern Regional Committee in its 369<sup>th</sup> meeting held on 28.01.2019. The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order. Accordingly, as per the decision of SRC show cause notice was issued to the institution on **30.04.2019**. The institution has not submitted reply to the show cause notice.

4. **AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a Final Show Cause Notice was issued on **11.10.2019**. The institution vide letter received on 15.11.2019 submitted reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the matter was further considered by the SRC in its 393<sup>rd</sup> meeting held on January 5<sup>th</sup> – 6<sup>th</sup>, 2021 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the representation submitted by the institution in response to the Final Show Cause Notice issued to the institution, and the Committee found the following deficiencies: -

1. The institution has submitted a Lease Deed dt. 12.05.2006 with a lease period of 2006 to 2011 at the time of initial recognition granted to the institution. But, now, at the time of reply submitted by the institution on 15.11.2019 in response to the final show cause notice, the institution has submitted a same Lease Deed which is manually tempered and the Lease Period is clearly tempered (Over writing on Lease Period 01.06.2006 to 31.05.2036.)
2. The institution has submitted photocopy of land title certificate different survey no.
3. The institution has not submitted BCC.
4. The institution has submitted photocopy of list of faculty. A letter regarding approval of faculty issued by the affiliating body has not submitted by the institution.
5. The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.

Hence, the Committee decided to **withdraw the recognition** granted to **Sri Sainath College of Education, Sri Shiridi Sainath Education, Ac./o.k.m.d Axmathulla, H.No.1, Channambatti Street, Yemmiganur, Kurnool District – 518360, Andhra Pradesh** for conducting B.Ed, course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Sri Sainath College of Education, Sri Shiridi Sainath Education, Ac./o.k.m.d Axmathulla, H.No.1, Channambatti Street, Yemmiganur, Kurnool District – 518360, Andhra Pradesh** run by **Sri Shiridi Sainath Educational Society, Vinayak, Nagar, RTC colony, Hayat Nagar, Hyderabad, Rangareddy District, Telangana** for conducting B.Ed. course of two years duration with an annual intake of **100** students w.e.f. the next academic session.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
