F.SRO/NCTE/APS07891/B.Ed/2010/21167 dated 17.09.2010 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, the SRC withdrawal order.F.No.APS07891/B.Ed/AP/2013-14/52065 dated 03.06.2013 was issued to the institution.
- 3. AND WHEREAS, the Southern Regional Committee in its 248th Meeting held on 13th 15th July, 2013 considered the Hon'ble High Court direction dt. 18-06-2013 and decided that the lawyer be asked to file an appeal by citing the Supreme Court order regarding strict enforcement of norms/standards, and to get the stay vacated.
- 4. AND WHEREAS, a letter dated 20-05-2014 from Sri Venkateswara University Tirupati, (Andhra Pradesh) is received by this office on 16-06-2014 regarding the affiliation of Munivenkata subba Reddy College of Education, D.No. 19-9-3 E/4, Motherland campus, Thiruchanoor By pass Road, Tirupati, 517507, Andhra Pradesh for the year 2013-14 as under:-

"Conditional affiliation is granted for the B.Ed course offered by the college for the academic year 2013-2014, subject of fulfilment of the conditions pointed out by the university inspection commission and the other general condition as laid down in chapter XI of the laws of the university and the conditions stipulated by the N.C.T.E./Govt. of AP from time to time. This affiliation order is granted subject to final disposal of the above writ petition filed in the Andhra Pradesh High Court, Hyderabad."

- 5. AND WHEREAS, the Southern Regional Committee in its 270th meeting held during 13th July,2014 considered the matter, decided and advised Southern Regional Office to:
 - 1. Ascertain the current status of the case. The Lawyer has not responded for over a year now.
 - 2. If the 'stay' is still in force, the Lawyer should get it vacated soon.
- 6. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 26.02.2015 for its willingness for adherence of provisions of new

Regulations. A Revised Provisional Recognition Order was issued to the institution on 29.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

- 7. AND WHEREAS, the SRC vide order no. F.SRO/APS07891/B.Ed/AP/2016/83405 dt. 05.04.2016 was issued to the institution for shifting of premises to new location at Muni Venkata Subba Reddy College of Education, Plot No. 9-147/1A 1st Main Road, Damineedu Village, Head Post Office, Tirupati Rural Taluk, Chittoor District 517501, Andhra Pradesh.
- 8. AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Report accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, a First Show Cause Notice was issued to the institution on 10.12.2019. The institution vide letter received on 29.01.2020 submitted its reply to the First Show Cause Notice.
- 9. AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 21.10.2020.
- **10. AND WHEREAS**, the SRC in its 393rd meeting held on 05th 06th January, 2021 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Muni Venkata Subba Reddy College of Education, Plot No. 9-147/1A 1st Main Road, Damineedu Village, Head Post Office, Tirupati Rural Taluk, Chittoor District – 517501, Andhra Pradesh for the following courses:-

- (i) B.Ed 2 units (50 students each unit).
- (ii) M.Ed- 1 unit of 50 students.
- 11. NOW THEREFORE, this order is issued permitting the institution i.e. Muni Venkata Subba Reddy College of Education, Sy. No. 36/1, Plot No. 9-147/1A,v 1st Main Road, Damineedu Village, Head Post Office, Tirupati Rural Taluk, Chittoor District 517501, Andhra Pradesh run by Mandyam Educational Society, Chittoor District 517501, Andhra Pradesh for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (2 basic units) of subject to fulfillment of the following conditions:-
 - I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

- II.The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 12. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter:
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
