WHEREAS, the recognition was granted to the institution namely Sri Lakshmi Venkateswara College of Education, H.No. 1-47-1, Byreddy Nagar, Stantapuram Village, Kurnool Mandal, Kurnool District-518001, Andhra Pradesh run by Sri Lakshmi Venkateswara Educational Society, H.No. 40-809 B, Srinivasa Nagar, Kurnool-518004. Andhra Pradesh. The SRC vide order F.SRO/NCTE/APSO8167/B.Ed/2007-2008/12214 dt. 26.09.2007 for conducting (B.Ed.) course of two-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 05.01.2015. A Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- 3. AND WHEREAS, the SRC in its 363rd meeting held on 17th & 19th September 2018 considered the matter and decided to SCN. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 17.10.2018. The institution vide letter dated 01.11.2018 submitted its reply to the show cause notice.
- 4. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the matter and decided to issue First SCN. Accordingly, as per the decision of SRC a First Show Cause Notice was issued to the institution on 20.11.2019. The institution vide letter dated 20.11.2019 submitted reply to the First SCN.
- 5. AND WHEREAS, the matter was further considered by the SRC in its 393^{rd} meeting held on January $5^{th} 6^{th}$, 2021 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the representation submitted by the institution in response to the Final Show Cause Notice issued to the institution, and the Committee found the following deficiencies: -

- 1. The institution has not submitted notarized english version of registered land documents.
- 2. The institution has not submitted LUC duly approved by the competent authority
- 3. The institution has not submitted notarized english version of NEC.

- 4. The institution has not submitted original blue prints of Building Plan & Site Plan duly approved by the competent authority.
- 5. The institution has submitted Building Completion Certificate which not in prescribed format.
- 6. The institution has submitted photocopy of faculty list but not approved by affiliating body & Date of appointed are not mentioned. A letter regarding approval of faculty issued by the affiliating body has not submitted by the institution.
- 7. The institution has not submitted Form 'A' issued by the Branch Manager. The institution is required to submit Form "A" issued by the bank manager towards creation of FDR of Rs. 7 lakh & Rs. 5 lakhs towards Endowment Fund & Reserve Fund.

Hence, the Committee decided to withdraw the recognition granted to Sri Lakshmi Venkateswara College of Education, H.No. 1-47-1, Byreddy Nagar, Stantapuram Village, Kurnool Mandal, Kurnool District-518001, Andhra Pradesh for conducting B.Ed, course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sri Lakshmi Venkateswara College of Education, H.No. 1-47-1, Byreddy Nagar, Stantapuram Village, Kurnool Mandal, Kurnool District-518001, Andhra Pradesh run by Sri Lakshmi Venkateswara Educational Society, H.No. 40-809 B, Srinivasa Nagar, Kurnool-518004. Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website
