WHEREAS, the recognition was granted to the institution namely Prathibha College of Education, Sy No. 153, Soharapuram, Kurnool District-518002, Andhra Pradesh run by Sai Prathibha Educational Society, House No. 87/1328, Engineers Colony, Nandyal Road, Kurnal-518002, Andhra Pradesh. The SRC vide order dt. 31.10.2008 for conducting (B.Ed.) course of two-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, as per records, the file was under process and in the meanwhile, in view of the recommendation of the State Government of Andhra Pradesh not to further recognize/permit the institutions for conducting B.Ed, D.Ed, Physical Education, Language Pandit courses, a public notice was issued on 01.10.2008 to this effect that application for B.Ed, D.Ed, Physical Education, Language pandit Courses from the states of Andhra Pradesh will not be considered for the academic session 2009-2010 and all such applications shall be returned along with processing fees and documents.
- 3. AND WHEREAS, the SRC in its 169th meeting held on 12-13th January 2009 having considered the letter dated 07.01.2009 of State Government of Andhra Pradesh and decided to give effect to the decision of State Government of Andhra Pradesh as such with immediate effect.
- 4. AND WHEREAS, a letter dated 20.03.2009 forwarded by Principal Secretary of Education requesting not to accord further recognition/premises to the new colleges/private B.Ed, D.Ed, Physical Education, Language Pandit in the state of Andhra Pradesh as the above colleges are exceeding in numbers than required.

Hence the application (APS0 9749) for recognition/permission for B.Ed course, received in the office of SRC on 31.10.2008 was returned along with documents, processing fee of Rs. 40,000 vide DD bearing no. 044670 dated 30.04.2009 and the application submitted by Sai Prathiba Educational Society, Prathiba college of Education, Plot No. 87-1328-A, Engineer Colony, Kurnool District-518002, Andhra Pradesh is here by closed.

Accordingly, closure order was issued to the applicant institution on **05.05.2009** as per direction of Regional Committee.

- **5. AND WHEREAS,** the institution has approached the Hon'ble High Court of Andhra Pradesh in W.P.No.30729 / 2010. The Hon'ble High Court order dated **16.06.2011**.
- 6. AND WHEREAS, the Southern Regional Committee in its 272^{nd} Meeting held during $1^{st}-2^{nd}$ September, 2014 considered the matter. Hon ble High Court of Hyderabad, judgment dated 27.07.2011, letter from the institution dated 16.08.2014, decided and advised Southern Regional Office to ask our Lawyer to report immediately on the status of our decision to file an appeal against the High Court Order. As per the decision of SRC, a letter was addressed to the advocate Shri. Ramakanth Reddy on 10.10.2014 requesting him to report the status of appeal which was to be filed in W.P.No. 30729 of 2010 as per the decision of 211th meeting of SRC.
- 7. **AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated **30.12.2014**.

- AND WHEREAS, The SRC in its 280th meeting held on 12th -14th February, 2015 decided as under:-
 - 1. LOI for B.Ed (1 basic unit).

2. Ask them to reply if possible by 25 Feb, 2015 so that this case can be considered for FR before 03.03.2015.

Accordingly, a Lol was issued to the institution on 16.12.2015. On 24.02.2015, the institution has submitted a written representation along with relevant documents.

AND WHEREAS, the SRC in its 282nd meeting held on 26th February, 2015 decided as under:-

Formal Recognition for B.Ed (2 basic units) w.e.f. 2015-16.

- AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 03.03.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered 11. the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per the decision of SRC a First Show Cause Notice was issued to the institution on 06.12.2019 The institution did not reply to the First Show Cause Notice.
- AND WHEREAS, The SRC in its 383rd meeting held on 07th to 09th January 2020 decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 16.01.2020. The institution submitted its reply to the Final SCN vide letter dated 03.02.2020.
- AND WHEREAS, the matter was further considered by the SRC in its 393rd meeting held on 13. January 5th - 6th, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the representation submitted by the institution in response to the Final Show Cause Notice issued to the institution, and the Committee found the following deficiencies: -

- 1. The institution has not submitted original blueprints of the Building Plan duly approved by the competent authority.
- 2. The institution has not submitted original blueprints of the Site Plan duly approved by the competent authority.

Hence, the Committee decided to withdraw the recognition granted to Prathibha College of Education, Sy No. 153, Soharapuram, Kurnool District-518002, Andhra Pradesh for conducting B.Ed, course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Prathibha College of Education, Sy No. 153, Soharapuram, Kurnool District-518002, Andhra Pradesh run by Sai Prathibha Educational Society, House No. 87/1328, Engineers Colony, Nandyal Road, Kurnal-518002, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.

15. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

16. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
