RECOGNITION ORDER

WHEREAS, the institution namely Sree Krishna College of Education, Porayar Village. Trangbar Mandal, Porayar Town, Nagapattinam District-609307, TamilNadu run by Sree Krishna Educational and Charitable Trust, Porayar Village, 69, Alarveli Road, Tharangambadi Mandal, Porayar Town, Nagapattinam District-609307, TamilNadu had submitted an application seeking grant of recognition of M.Ed. programme for two years duration for the academic year 2017-18 under Section 14/15 of the NCTE Act, 1993 to the Southern Regional Committee, NCTE through online on 31.05.2016. The institution submitted the hard copy of the application on 15.06.2016.

- 2. AND WHEREAS, the SRC in its 335th meeting held on 11th - 12th April, 2017 considered the matter and decided to issue rejection order. Accordingly, as per the decision of SRC rejection order no. F.No. SRO/NCTE/SRCAPP201630070/M,Ed/TN/2017-18/92866 dated 19.04.2017 was issued to the institution.
- 3. AND WHEREAS, the institution filed a W.P.No. 20852 of 2021 before the Hon'ble High Court of Madras. The Court vide order dated 08.10.2021 directed as under:-

"In the considered view of this Court, the application was submitted by the partitioner seeking for recognition for the M.Ed. Course in the year 2017. Nealy four years have gone by and it is not feasible to resurrect or restart the approval process of the year 2017. It will therefore be more appropriate if the petitioner makes a fresh application to the second respondent seeking for recognition for M.Ed course. While making such application, it will also be left open to the petitioner to give a representation along with the application by taking a specific stand as to why the basis of rejection in the year 2017, is not in accordance with the regulations. This clarity is required since there is an apprehension in the mind of the portioner that the very same ground will put against the petitioner while considering the recognition this time also. On receipt of the application from the petitioner along with the representation, it is left open the second respondent to deal with the same strictly in accordance with law."

- AND WHEREAS, the institution has submitted reply on 08.12.2021. The SRC in its 406th meeting held on 19th January, 2022 considered the matter and decided to issue LOI. Accordingly, as per the decision of SRC a letter of intent was issued to the institution on 04.02.2022. The institution has submitted reply on 15.02.2022.
- 5. AND WHEREAS, the SRC in its 407th meeting held on 15th February, 2022 has considered the matter and decided as under:-

On the perusal of the original documents and records submitted by the institution on 15.02.2022 in respect of LoI issued u/s 7(13) of NCTE Regulations, the Committee decided to grant Recognition to Sree Krishna College of Education, Porayar Village, Survey No. 131-1, 132-1A, 132-1B, 132-2, 132-3, 132-4 & 133, No. 69, Allarvelli, Porayar, Tharangambadi (T.K.), Nagapattinam District-609307, Tamilnadu for conducting M.Ed. Programme for one basic unit of 50 students from the academic session 2022-2023 under clause 7(16) of the NCTE Regulations, 2014.

- 6. NOW THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act 1993, the Southern Regional Committee, NCTE hereby grants recognition to Sree Krishna College of Education, Porayar Village, Tranqbar Mandal, Porayar Town, Nagapattinam District-609307, TamilNadu run by Sree Krishna Educational and Charitable Trust, Porayar Village, 69, Alarveli Road, Tharangambadi Mandal, Porayar Town, Nagapattinam District-609307, TamilNadu for conducting M.Ed. Programme for two-year duration with an intake of 50 students (one basic unit) from the academic sessions 2022-2023 under Clause 7(16) of NCTE (Regulation Norms & Procedure) Regulation, 2014 subject to fulfillment of the following conditions.
 - (a) The institution shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014, as amended from time to time, and ensure the following before commencement of the session:-
 - (i) The institution shall comply with various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
 - (ii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of Clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - (iii) The institution shall comply with condition laid down in clause 8(3) of the NCTE Regulations, 2014, as amended vide Notification on 29.04.2017. which provides as under:-
 - An institution, which has been recognised by the Council shall obtain accreditation from an accrediting agency identified by the Council within five years of the date of recognition.
 - All existing Teacher Education Institutions which have not been accredited so far or have not been accredited within five years from the date of its recognition shall be required to get themselves accredited by the aforesaid accrediting agency within a period of one year from the date of notification of these Regulations.

- The accreditation once obtained shall be valid for a period of five years and the recognised and already accredited Teacher Education Institutions shall be required to get accreditation renewed by the agency identified for the purpose by the Council before the lapse of the earlier accreditation.
- (iv) The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- (v) The Norms for teaching staff in respect of their qualifications and experience shall be as per provisions of NCTE Regulations, 2014, as amended from time to time.
- 7. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable, and compliance of the following by the affiliating body, State Govt. and also the concerned recognized Institution:-
 - (i) The affiliating body/State Govt. shall be required to verify the authenticity of the land & building documents submitted by the institution, with the required land & built up area as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 before grant of affiliating to the institution.
 - (ii) The affiliating university shall ensure that the norms including the norms of Faculty for offering B.Ed-Al. component of the programme as per curriculum of these programme in the University, is scrupulously observed.
 - (iii) The affiliating body shall ensure that the institution is a composite institution as per definition of a "composite institution" given in the NCTE Regulations, 2014. If at any stage, it is found that the institution is not a composite institution, the recognition granted shall be treated as withdrawn and the sole responsibility of the same will be of the institution. However, the existing stand-alone institutions.
 - (iv) The NOC of the affiliating body and staff approval thereof submitted by the institution, if found fake, at any stage, the recognitions granted shall be treated as withdrawn, and the sole responsibility of the same will be of the institution.
- 8. The institution shall submit a Self-Appraisal Report to the Regional Committee at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display as mandatory disclosure the following:-
 - (i) Copy of Application Form
 - (ii) Land and Building Particulars
 - (iii) Staff Profile
 - (iv) Recognition Order

- (v) Information regarding fulfilment of norms & standards and other conditions for the course.
- 10. In case, if the land is in the name of the Society/Trust, the land is to be transferred within six months from the date of recognition order in the name of the institution, failing which action shall be initiated for withdrawal of recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the Regional Committee along with new land documents within the stipulated time.
- 11. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by the MHRD.
- 12. The Institution shall fill the GIS Application within one month from the date of issue of this order.
- 13. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules and Regulations, the Regional Committee shall withdraw recognition under provisions of Section 17(1) of the NCTE Act, 1993.
- 14. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
