WHEREAS, the recognition was granted to the institution namely Satyam D.Ed College, Plot No. 348 & 555, 1st Street, Pyalakurth Village & Post, Kodumur Taluk, Kurnool District-518464, Andhra Pradesh for conducting D.El.Ed & D.El.Ed-Al course following teacher training courses:-

- (i) The SRC vide Order No. SRCAPP512/D.El.Ed/AP/2012/45634 dated 29.08.2012 for conducting D.El.Ed. course of two-year duration with an annual intake of 50 students from the academic sessions 2012-2013.
- (ii) The SRC vide order No. SRO/NCTE/SRCAPP2795/D.El.Ed.-Al/AP/2016-17/83778 dated 11.04.2016 for conducting D.El.Ed-Al. programme of two-year duration with an annual intake of 50 students from the academic sessions 2016-2017.
- 2. AND WHEREAS, a letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. Colleges in A.P. since the said managements of Pvt. D.El.Ed. Colleges have made admission into the D.El.Ed. Course during academic year 2018-19 on their own in violation of Government orders.
- 3. AND WHEREAS, the matter was considered by SRC in its 386th meeting held on 23rd 24th July, 2020 and decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 05.08.2020. The institution has submitted its reply to the Show Cause Notice on 31.08.2020.
- **4. AND WHEREAS,** The SRC in its 401st meeting held during 11th 12th August, 2021 considered the matter and decided as under;

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

1. The Committee in its 386th meeting after perusal of the letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt.D.El.Ed. colleges in A.P. since the said managements of Pvt.D.El.Ed. colleges have made

admissions into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders. Accordingly, the SRC decided to issue a Show Cause Notice to all such institutions asking therein to explain about the observations made by the School Education Department, Govt. of Andhra Pradesh vide letter No. R.C.No. 359/A/SCERT/2019 dated 29.6.2020.

- 2. In view of the above decision a Show Cause Notice dated 05.08.2020 was issued to the institution and the institution vide dated 28.08.2020 has submitted its representation. The institution failed to submit satisfactory explanation on the observation made by the School Education Department, Govt. of AP is not satisfactory as the institution made admission into the D.El.Ed. course during academic year 2018-19 on their own in violation of Govt. orders.
- 3. Further on perusal of the reply on 28.08.2020submitted by the institution, the institution also failed to submit the following documents/information:
 - a) The institution has submitted photocopy of land documents instead of certified copy/attested copy.
 - b) The institution has submitted notarized copy of building and site plan but not readable.
 - c) The institution has submitted copy of "Form A" issued by the respective Bank Manager but not in prescribed format.
 - d) The institution has submitted faculty approval letter approved by director of SCERT vide letter dated 26.02.2016. the latest list and approval not submitted but the same is not the latest one.
 - e) The institution has not satisfactorily replied with reference to irregularities made by the institution as pointed out by the School Education Department Government of Andhra Pradesh vide letter No. 359/A/SCERT/2019 dated 29.06.2020.

Hence, the Committee decided to withdraw the recognition granted to Satyam D.Ed College, Plot No. 348 & 555, 1st Street, Pyalakurth Village & Post, Kodumur Taluk, Kurnool District-518464, Andhra Pradesh for conducting D.El.Ed. alongwith additional intake programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

5. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Satyam D.Ed College, Plot No. 348 & 555, 1st Street, Pyalakurth Village & Post, Kodumur Taluk, Kurnool District-518464, Andhra Pradesh for conducting D.El.Ed. alongwith additional intake programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such

course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
