WHEREAS, the recognition was granted to the institution namely Mother Teresa College of Education, 669, Raigir Village, Bhongir Mandal, Nalgonda District – 508006, Andhra Pradesh vide SRC (NCTE) order No F.SRO/NCTE/APSO2657/B.Ed/2004-2005/1090 dated 08.03.2005 for Secondary B.Ed. Course of one-year duration from the academic session 2004-2005 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 18.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- **3. AND WHEREAS,** the SRC in its 317th meeting held on 28th & 30 July, 2016 considered the matter and decided issue Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 10.08.2016.
- **4. AND WHEREAS,** the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a Final Show Cause Notice was issued on 21.11.2019. the institution has not submitted reply of Final Show Cause Notice.
- **5. AND WHEREAS,** the SRC in its 392^{nd} Meeting held on 15^{th} - 16^{th} December, 2020 considered the matter and decided *to* withdraw the recognition for conducting B.Ed. Programme. Accordingly, as per the decision of SRC a withdrawal order No F:SRO/NCTE/APS 02657/B.Ed/TS/2020/122106-2112, dated 29.12.2020 was issued to the institution.
- **6. AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. F.No.89-90/E-178819/2021 Appeal/12th Mtg.-2021/28th May, 2021 dated 02.06.2021 appeal remand back the Order appealed against. The institution has submitted reply of Appeal Reminds Back Case on 21.06.2021.
- 7. AND WHEREAS, the SRC in its 400^{th} meeting held on $13^{th} 14^{th}$ July, 2021 considered the matter and decided as under:-

The Committee on perusal of the reply submitted by the institution namely Mother Teresa College of Education decided that shifting of premises be permitted to the institution at new address i.e. Survey No. 132/I, 132, Anantharm Village, Bhongir (M), Nalgonda District-508116, Telangana. The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 2 basic units of 50 students each".

8. NOW THEREFORE, this order is issued permitting the institution i.e., Mother Teresa College of Education, Plot No. 669, Raigir Village, Bhongir Mandal, Nalgonda District – 508006, Telangana to shift its building at new address at Survey No. 132/I, 132, Anantharm Village, Bhongir (M), Nalgonda District-508116, Telangana run by V.J.R. Memorial Educational Society, Anantharam Village, Bhongir Mandal, Yadadri-Bhongir District-508116, Telangana Further as per the decision of the SRC, an order for continuation of recognition for B.Ed. Programme of two years duration with an intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **10.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. - e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **12**. The institution shall adhere to the mandatory disclosure in the prescribed format and display upto-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.
