WHEREAS, the recognition was granted to the institution Shivparvathi Mandradiar Teacher's College, Palayakottai P.O, Erode-Via, Erode District, Tamilnadu-638108 run by Shivparvathi Mandradiar Educational Trust vide SRC order No. F.SRO/NCTE/M.Ed./2006-2007/13924 on 01.11.2007 for conducting M.Ed. programme of two-year duration with an annual intake of 25 students.

- 2. AND WHEREAS, the consequent upon the notification of the National Council for Teacher Education (Amendment) Regulation, 2010 on dt. 26.07.2010 the intake of existing 25 students in M.Ed. course was increased from 25 to 35 vide SRC, NCTE order dt. 25.08.2010.
- 3. AND WHEREAS, a Corrigendum was issued to the institution vide order no. F. No.APSO7226/M.Ed./TN/2013-2014/53868 dt. 19.09.2013 for the name of the institution notified as "Mandradiar College of Education, Kangayam to Erode Road, Palayakottai Post, Erode District, Tamilnadu" to "Shivparvathi Mandradiar College of Education, Kangayam to Erode Road, Palayakottai Post, Erode District, Tamilandu."
- 4. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 23.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, revised provisional recognition order was issued to the institution on 25.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 (one unit) from the academic session 2015-16.
- 5. AND WHEREAS, the SRC in its 388th Meeting held on 14th & 15th September 2020 considered the matter and decided to issue another SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the regional Committee. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 08.06.2021. The institution submitted its reply on 28.06.2021.
- 6. **AND WHEREAS**, the SRC in its 401st meeting held on 13th 14th July, 2021 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 31.08.2021. The institution has submitted its reply on 11.10.2021.
- 7. AND WHEREAS, the SRC in its 403rd Meeting held on 18th & 19th October, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- 8. NOW THEREFORE, this order is issued permitting the institution i.e., Shivparvathi Mandradiar College Education, Survey No. 361/2, 362/2, Door No. 1/1, Pudhu Sakarapalayam, Palayakottai, P.O., Erode-Via, Erode District, Tamilnadu-638108 run by Shivparvathi Mandradiar Educational Trust, Tirupur District, Palayakottai, Tamilnadu-638108 for Continuation of recognition for M.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **10.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. - e. Fee charged from students.
- Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **12**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
