- 3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Mother College of Education, Jagannadhapuram, Kotananduru Mandal. East Godavari-533407. Andhra Pradesh for conducting Secondary(B.Ed) course of one year duration with an annual intake of 100(Hundred) students under clause 7(12) of Regulations dated.13.01.2006. - i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
- ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- iii) The institution will ensure that **Principal and Seven** faculty members duly approved by the affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.

- The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
