WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Kasthurba Gandhi Kanya Gurukulam for Women, # 810, Verdaraniam-614810, Nagapattinam District, Tamilnadu run by Kasthurba Gandhi Kanya Gurukulam, Vedaraniam-614810, Nagapattinam District, Tamilnadu vide order No. F.SRO/NCTE/B.Ed./2009/14262 dated 30.06.2009 for conducting Secondary (B.Ed.) Course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 24.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 23.03.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. **AND WHEREAS**, the SRC in its 369th meeting held on 28 01.2019 considered the matter and the Committee decided to issue a Show Cause Notice in compliance of RPRO. Accordingly, a Show Cause Notice dated 14.08.2019 was issued to the institution. The institution submitted reply of show cause notice vide dated 20.09.2019.
- **4. AND WHEREAS,** the SRC in its 386th meeting held on 23-24 July 2020 considered the matter and the Committee decided to issue a Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 04.08.2020. The institution was submitted not submitted reply of Final Show Cause Notice.
- **5. AND WHEREAS**, the SRC 396th meeting held on 3rd March 2021 considered the matter and committee decided to withdrawal the recognition. Accordingly, as per decision of SRC a withdrawal order No. F.SRO/NCTE/APS03576/B.Ed./TN/2021 /125225-5232 dated 16.03.2021 was issued to the institution.
- 6. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-248/E-277843/2022 Appeal/11th Meeting, 2022 APPLSRC202114059 dated 11.01.2023 appeal remand back the order appealed against. The institution vide letter dated 19.01.2023 submitted reply to the appeal remand back.

7. **AND WHEREAS**, the SRC in its 421st meeting held on 10th February 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Kasthurba Gandhi Kanya Gurukulam for Women, Survey No. 633, Verdaraniam, Nagapattinam District, Tamilnadu-614810 for B.Ed. programme for 2 basic units of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Kasthurba Gandhi Kanya Gurukulam for Women, Survey No. 633, Verdaraniam, Nagapattinam District, Tamilnadu-614810 for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic unit) of 50 students each subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **10.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure,

- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **12**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- **13.** The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
