WHEREAS, recognition was granted to the institution namely Kondapally Pydithalli Naidu College of Education, Vizianagaram, Revenue Division, Gantvada, Vizianagaram District Andhra Pradesh-535215 run by Pydithallamma Vydya Gidhnana Society Srinivasa Nilyam Near St: Joshes School Cantonment Vizianagaram-535215 vide SRC (NCTE) order no. F.AP/NEW/B.Ed/179/SRO/NCTE/2002-2003/6671 dated 09.04.2002 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 30.01.2015 and the provisional revised recognition order was issued on 06.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, on the basis of request, the SRC in its 342^{nd} meeting held on $5^{th}-6^{th}$ July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, a order was issued to the institution on 21.07.2017 reduction of intake from 2 units to 1 unit.
- 4. AND WHEREAS, the SCN/FSCN was considered by the sub-Committee constituted by the SRC in its meeting held on 22 Oct, 2019.the Sub-Committee noted that institutions have d submitted requisite documents or only part reply has been submitted. Accordingly, as per the decision a First Show Cause Notice was issued to the institution on 24-10-2019. The institutions vide letter dated 11.11.2019 submitted reply to the First Show Cause Notice along with documents.
- 5. AND WHEREAS, the SRC in its 384 meeting held on 12th & 13th February, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 26.02.2020. The institution has submitted reply on 26.02.2020 the basis of minutes uploaded on website.
- 6. AND WHEREAS, the SRC in 393rd meeting held on 05th -06th January 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC, withdrawal order was issued to the institution on 08.01.2021 vide order no. F.SRO/NCTE/APSO0348/B.Ed./AP/2021/122734-2739.

- 7. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-105/E-180238/2021 Appeal/21st Meeting, 2021 Appeal No.APPLSRC202113966 dated 22.10.2021 Appeal Committee of the Council concluded to confirm the impugned order of withdrawal issued by SRC.
- 8. AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Andhra Pradesh at Amravati for bearing W.P (C) No. 16143/2022 titled as Kondapalli Pydithalli Naidu College of Education and others Versus State of Andhra Pradesh and others Whereby the Hon'ble High Court has directed that: -

"Accordingly the writ petition is allowed at the stage of admission setting aside the order in F.SRO/NCTE/APSO0348/B.Ed/AP/2021/122735, dated 08.01.2021 passed by the 2nd respondent as well as the order in file no. 89-105/E-180238/2021, dated 22.10.2021, passed by the Appellate Authority, National Council for Teacher Education (NCTE), New Delhi and the matter is remitted back to the 2nd respondent to issue a fresh Show Cause Notice to the petitioner, if it is so advised, and thereafter only pass appropriate orders in accordance with law, after affording an opportunity to the petitioner, within a period of four (4) weeks from the date of receipt of a copy of this order. No order as to costs."

- 9. AND WHEREAS, the SRC in 417th meeting held on 01st & 2nd December 2022 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 12.12.2022. The institution has submitted reply on 05.01.2023.
- **10. AND WHEREAS,** the SRC in its 419th Meeting held on 13th January, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Kondapally Pydithalli Naidu College of Education, Survey No. 283/8,9,11,13,14,15,300/6,8,9, 301/1,4,5,7,8,10,14,16,17,18,20,23,27,3,12, Grantyada Gram Panchayat, Ganthyada, Vizianagaram, District-535215, Andhra Pradesh for B.Ed. programme for 1 basic unit of 50 students."

The Committee further decided that the above said decision will be subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR).

- 11. NOW THEREFORE, this order is issued permitting the institution i.e., Kondapally Pydithalli Naidu College of Education, Survey No. 283/8,9,11,13,14,15,300/6,8,9, 301/1,4,5,7,8,10,14,16,17,18,20,23,27,3,12 Grantyada Gram Panchayat, Ganthyada, Vizianagaram, District-535215, Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR) and fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **12.** Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc. \

- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **15.** The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- **16.** The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
