WITHDRAWAL ORDER

WHEREAS, recognition u/s14 (1) of NCTE Act, 1993 was granted to the institution namely, **J.K. Teacher Training Institute, 4/360, J.K. Nagar, Dindigul-624001, TamilNadu** run by **Vedasandur Rajathiammal and Rengasamy Chettiar Trust, Dindigul District-624001, TamilNadu** vide SRC (NCTE) order no. F.TN/825/SRO /NCTE/2004-05/218 dated 20.01.2005 for conducting (D.El.Ed.) Elementary Course of two years duration with an annual intake of 50 students from the academic session 2004-2005.

2. **AND WHEREAS**, the SRC in its 198th meeting held on 15th – 16th September 2010 has considered the matter and decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 06.01.2011.

3. **AND WHEREAS**, the SRC in its 204th meeting held on 27th – 28th April 2011 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 27.05.2011. The institution has submitted a reply to the Final Show Cause Notice on 29.06.2011.

4. **AND WHEREAS**, the SRC in its 211th meeting held on 21st – 23rd September 2011 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 09.11.2011.

5. **AND WHEREAS**, a letter dated 17.08.2021 was received from the institution regarding withdraw of the recognition for D.El.Ed. programme.

6. **AND WHEREAS**, the SRC in its 414th Meeting of SRC held on 26th – 27th September 2022 considered the matter request for withdrawal of the D.El.Ed. Programme and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 17.08.2021 by withdrawing the recognition granted to

J.K. Teacher Training Institute, 4/360, J.K. Nagar, Dindigul-624001, TamilNadu for conducting **D.El.Ed. Programme** under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting”.

7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted **J.K. Teacher Training Institute, 4/360, J.K. Nagar, Dindigul-624001, TamilNadu** run by **Vedasandur Rajathiammal and Rengasamy Chettiar Trust, Dindigul District-624001, TamilNadu** for conducting **D.El.Ed. Course** of two years duration with an annual intake of 50 students (one unit) with effect from the academic session i.e., 2022-2023 as requested by the institution.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

“यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।”



9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
