ORDER

WHEREAS, Sri Venkateshwara Vidhyalaya College of Education, Sri Vaishnavi Devi Nagar, Thasampalayam, P.K. Palyam(Post), Gobichettipalayam Taluk, Erode-638476, Tamilnadu had submitted the applications for D.T.Ed & B. Ed Courses on 21.12.2004. The institution was granted recognition on 17.11.2005 for D.T.Ed course & on 06.07.2005 for B.Ed course, with an annual intake of 100 students, with the condition to shift to own premises within 3 years from the date of recognition.

AND WHEREAS, NCTE Hqs vide its letter dated 24.06.2011 forwarded a copy of the inspection report dated 05.05.2010 conducted under Section 13 of NCTE Act. As there were deficiencies pointed out in the inspection report, NCTE Hqs requested SRC to look into the matter in order to ascertain the compliance/adherence of the NCTE Norms and Standards by the institution and also to take appropriate action.

AND WHEREAS, the matter was considered by the Committee and it was decided to cause composite Shifting inspection of the institution for B.Ed (APSO3739) & D.T.Ed (APSO3735) Course, under Section 17 of NCTE Act, to verify the facts and directed to submit all relevant documents. Also the Committee considered the VT Report (as per Section 13 inspection) and decided to combine the deficiencies of Sec. 13 inspection. Sri Venkateshwara Vidhyalaya Teacher Training Institute, Sri Vaishnavi Devi Nagar, Thasampalayam, P.K. Palyam(Post), Gobi Taluk, Erode-638476, Tamilnadu. Accordingly, inspection was carried out on 15.02.2012.

AND WHEREAS, the Committee in its 224th meeting held on 14-16th June 2012 considered the VT report, VCD and all the relevant documentary evidences and it was decided to serve Final Show cause Notice under NCTE Act. Accordingly, show cause notice was issued to the institution on 09.07.2012. The institution submitted its reply on 16.08.2012.

The institution has replied vide letter dt.16.08.2012 for the deficiencies pointed in the show cause notice:

- The institution has not replied the point No. 1 of Show Cause Notice properly. Nothing has been stated with regard to lease deed dated 20.10.2004. Moreover, the institution has now submitted notarized English version of the same sale deed(s) submitted on earlier occasion, however the title of land has now been stated in favour of Trust instead of an individual.
- Certified copy of gift deed dated. 28.12.2004 is not submitted. Only notarized English version is submitted stating the land in the name of running institution.

- c) Blue print of the building plan is not approved by any of the authority.
- d) As per Building completion certificate dated 15.02.2012 (p-227/c) handed over to VT members, there was four storied building with built up area of 34,179 sq.ft, however, as per Building completion certificate dated 19.07.2012, building is three storied with built up area of 27,713 sq.ft. First page of this Building completion certificate is also not signed by the civil authority.
- e) Built up area of 27,713 sq.ft is grossly inadequate to run B.Ed & D.T.Ed course.
- f) Sy. Nos. shown in Land usage certificate dated 06.08.2012 are not tallying with Building plan and Building completion certificate.
- g) Original Non Encumbrance certificate in regional language is not submitted.
- h) As per entries at Sl. No. 9 & 10 of Non Encumbrance certificate (nolarized English version), the property is mortgaged in State Bank of India (Gobi Branch).
- i) As per staff details provided by the institute at p-325/c, only 1+4 staff is working against the requirement of 1+6 staff.
- j) Staff profile of Smt. Thiru.N.Chitra has not been handed over to VT members. While she has been approved as Lecturer on 06.01.2009.
- k) Lecturer in Foundation/Fine Arts/Physical Education are not appointed for D.T.Ed course.
- l) Comprehensive staff profile showing all details including % of marks, designation & experience has not been submitted for any of the courses(s).
- m) Part time Lecturer in Fine Arts/Physical Education are not appointed for B.Ed course.
- n) Lecturer in Foundation course is not appointed for B.Ed course.

The reply to the show cause notice is not satisfactory and unconvincing.

AND WHEREAS, based on the above points the Southern Regional committee Meeting in its 237th Meeting held on 05th-06th January 2013 has decided to withdraw the recognition of all the 2 course Viz: 1) D.T.Ed (APS03735), & B.Ed (APS03739) courses run by Sri Venkateshwara Vidhyala College of Education, Sri Vaishnavi Devi Nagar, Thasampalayam, P.K. Palyam (Post), Govichellipalayam Taluk, Erode - 638476, Tamilnadu from the academic year 2013-14, in order to enable the ongoing batch of students in both D.Ed & B.Ed courses, if any, to complete their course.

AND WHEREAS, but it is made clear that the institution is debarred from making any further admission subsequent to the date of issue of this order.

AND WHEREAS, the Affiliating body / Examining board / body be informed accordingly.

AND WHEREAS, further decided to return Endowment funds and Reserve fund deposited with SRC NCTE, Bangalore if any, subject to submission of letter from affiliating body/University that no admission are made by the institution further and No due certificate from the staff of the institution regarding payment of salary.

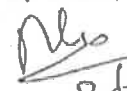

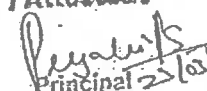

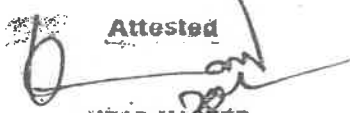
