

AND WHEREAS, the recognition was granted to the institution namely, Darul Uloom Training College, Vazhakkad P.O Pin-673640 Malappuram District, Kerala run by Vazhakkad Darul-Uloom Association vide SRC (NCTE) order No. F.KL/SEC/N/157/SRO/NCTE/2005-2006/4123 dated 22.11.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations.
- AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, the institution submitted written representation dated 04.06.2015 requesting therein for reduction of strength from 2 units to 1 unit in its B.Ed. course.
- 5. AND WHEREAS, Corrigendum vide а SRO/NCTE/APSO0574/B.Ed./KL/2015/68984 on 30.06.2015 was issued to the institution for reduction of strength from 2 units to 1 unit (50 students) from the academic section 2015-16.
- AND WHEREAS, the matter was further considered by the SRC in its 369rd meeting held on 28 January, 2019 and the Committee decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on 21.10.2019. The institution submitted its reply on 07.01.2020. The matter was further considered by the SRC in its 387th meeting held on August 24th & 25th 2020 and the Committee decided that to withdraw the recognition granted to the institution for B.Ed course. Accordingly, The Withdrawal Order issued to the institution on 07.09.2020.
- 7. AND WHEREAS, the institution has filed W.P. (C) 18878 of 2020 (H). In the High Court of Kerala at Ernakulam against withdrawal order dt. 07.09.2020. The Hon'ble High Court of Kerala passed an order dt. September 25, 2020.

- 8. AND WHEREAS, the matter was further considered by the SRC in its 391st Meeting held on 03rd November 2020 and the Committee decided sending a last reminder (Letter) Accordingly, Letter was issued on 19.10.2020. The institution submitted its reply on 01.12.2020.
- 9. AND WHEREAS, the matter was further considered by the SRC in its 392nd meeting held on 15th -16th December 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution has submitted Land Use Certificate dt 12.12.2019 signed by the Tahsildar, Kondotty, but the same has been issued for B.Ed college and CBSE English medium School whereas the occupancy certificate dt 12.11.2020 and the Building completion Certificate dt NIL certificate of specification and report of the proposed building issued by the Panchayat establishes the Built up area as 2784.86 sq.mtr which is not sufficient for both School as well as B.Ed course.

Hence, the Committee decided to withdraw the recognition granted to Darul Uloom Training College, Vazhakkad P.O Pin-673640 Malappuram District, Kerala for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 10. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Darul Uloom Training College, Vazhakkad P.O Pin-673640 Malappuram District, Kerala for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.
- 11. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

12. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
