ORDER

WHEREAS, the institution namely Christ Nagar College of Education, Chavarpuram, Thiruvallom, Thiruvananthapuram-695027, Kerala was granted recognition vide SRC (NCTE) order no. F. KL/SEC/N/152/SRO/NCTE/2004-2005/913 dt. 25.02.2005 for conducting Secondary B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by a notarized affidavit dt. 20.01.2015 consented to come under new Regulations.
- 3. AND WHEREAS, the Southern Regional Committee (NCTE) issued the Revised Provisional Recognition order dt.15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic units) from the academic session 2015-2016 subject to fulfilment of conditions mentioned therein.
- 4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 17.07.2019. The matter was further considered by the Sub-Committee constituted by the SRC as per its decision taken 380th meeting held from 18-19 September 2019. The sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, a Final Show Cause Notice was issued to the institution on 10.10.2019. The institution submitted its reply on 18.11.2019.
- 5. AND WHEREAS, the matter was further considered by the SRC in its 388th meeting held on 14th -15th September 2020 and the Committee decided to withdraw the recognition. Accordingly, The Withdrawal Order issued to the institution on 21.09.2020.
- 6. AND WHEREAS, the institution has filed W.P. (C) 20094 of 2020 (J). In the High Court of Kerala at Ernakulam against withdrawal order dt. 21.09.2020. The Hon'ble High Court of Kerala passed an order dt. October 13, 2020.
- 7. AND WHEREAS, the matter was further considered by the SRC in its 390th meeting held on October 28th 29 October,2020 & 391st meeting held on 03rd November,2020. Accordingly, Letter was issued on **09.11.2020**. The institution submitted its reply on 11.11.2020.

8. AND WHEREAS, the matter was further considered by the SRC in its 392nd meeting held on 15th -16th December 2020 and the Committee decided as under: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Christ Nagar College of Education, Chavarpuram, Thiruvallom, Thiruvananthapuram-695027, Kerala for B.Ed programme for 1 basic unit of 50 students

- 9. NOW THEREFORE, this order is issued permitting the institution continuation of conducting Christ Nagar College of Education, Chavarpuram, Thiruvallom, Thiruvananthapuram-695027, (Survey No. 195/3-1,195/4,286/4-6,286/2-4,286/3,207/13-1,207/13-2,207/13,286/3-1,196/1,196/2,291/1,291/3-1,287/3 Ward No. 65) Kerala run by Christ Nagar Educational Charitable Society. Christ Nagar, Kowdiar P.O. Trivandrum: Kerala-695003 for B.Ed. course of two years duration with an intake of 50 students (one basic units of 50 student) subject to fulfilment of the following conditions:
 - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 10. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure,

such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
