AND WHEREAS, the recognition was granted to the institution Gowthami Teacher Training Institute, Panchala Street, Yanam-533464, Union Territory of Pondicherry vide SRC (NCTE) order No F.PN/ELE/SRO/NCTE/2005-2006/3670 dt.24.10.2005 for conducting D.T.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, a show cause Notice under section 17of NCTE issued on Non-Maintenance of Norms and Standards by the teacher education Institutions recognized by SRC, NCTE on data 11.09.2009 to reply within 21 days. The institution submitted reply to Show Cause Notice on 23.10.2009. Further no action in file.
- 3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 381st meeting held on 31st October-01st November 2019 and the committee decided issue Show Cause Notice.
- 4. AND WHEREAS, accordingly, Show Cause Notice was issued on 01.09.2020 to reply within 30 days, reply of show cause notice on 09.10.2020 for close the institution.
- 5. AND WHEREAS, the matter was further considered by the SRC in its 392th meeting held on 15th 16th December 2020 and the Committee decided as follows:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to withdraw the recognition granted to Gowthami Teacher Training Institute, Panchala Street, Yanam533464, Union Territory of Pondicherry for conducting D.El.Ed course under clause 17(1) of NCTE Act, 1993 on its own request by the institution. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to to Gowthami Teacher Training Institute, Panchala Street, Yanam-533464, Union Territory of Pondicherry for conducting D.T.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act. -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
