CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Pallavan College of Education, Melmonavoor Village, Vellore Taluk, No.1, Bharathiyar Salai, Vellore-632010, Tamilnadu vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/10500 dated 03.02.2007 for conducting Secondary B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2006-2007.

- 2. AND WHEREAS, the SRC vide order no. F.No. APSO7517/B.Ed/TN/2012-13/49135 dated 15.02 2013 permitted the institution for shifting of premises to new location at Pallavan College of Education, Melmanavoor, N.H.46, Abdullapuram Post, Vellore Taluk, Vellore District- 632010, Tamilnadu.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 10.01.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting B.Ed. courses of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- 4. AND WHEREAS, the matter was further considered by the Sub-committee constituted by the SRC as per its decision taken in 381st meeting held on 31st October 01st November 2019 and decided to issue First Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. As per the decision a First Show Cause Notice was issued to the institution on 21.08.2020. The institution submitted its reply along with documents dt.14.09.2020.
- 5. AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October 2020 has considered the matter and the Committee decided to withdraw the recognition. Accordingly, a withdrawal order was issued to the institution on 23.10.2020.
- 6. **AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-253/E-170009/2020 Appeal/3rd Mtg-2021/20th January, 2021 dated 11.02.2021 appeal remand back the Order appealed against. The institution vide letter dated 19.02.2021 has submitted a reply in response to the Appeal Remand back.
- 7. AND WHEREAS, the SRC in its 395th meeting held on 25th 26th February, 2021 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 08.03.2021. The institution vide letter dated 08.03.2021 submitted reply to the Final Show Cause Notice.
- 8. AND WHEREAS, the matter was placed before the SRC in its 397th meeting held on 25th 26th March 2021 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution and decided that the continuation order be issued to the Institution Pallavan College of Education, Survey No. 304/1B1, 331/1B, 1C, 2, 3, 4, 332/1A, 334/1, 2A, 3, 335/3A, 3B, Melmonavoor Village, Vellore Taluk, Vellore District-632010, Tamilnadu for B.Ed. programme for 2 basic units of 100 students.

- 9. NOW THEREFORE, this order is issued permitting the institution i.e. Pallavan College of Education, Survey No. 304/1B1, 331/1B, 1C, 2, 3, 4, 332/1A, 334/1, 2A, 3, 335/3A, 3B, Melmonavoor Village, Vellore Taluk, Vellore District-632010, Tamilnadu run by Pallavan Charitable and Educational Trust, Tamilnadu for Continuation of recognition for B.Ed. programme for 2 basic units of 100 students subject to fulfilment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- 10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 13. The institution shall adhere to the mandatory disclosure in the prescribed format and display upto-date information on its official website.

- 14. The institution shall make available the list of students admitted on its official website.
- 15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
