Withdrawal Order 119797 21 OCT 2020

WHEREAS, the institution namely **Sai Ram College of Education, No. 14A, Pidari West Street, Sirkali, Nagapattinam District, Tamilnadu-609110** was granted recognition vide SRC (NCTE) order no. F.TN/ELE/NR-782/SRO/NCTE/2004-2005/9289 on dt. 10.12.2004 for conduction D.T.Ed. course of two years duration with an annual intake of 50 students from the academic session 2004-2005 and additional intake of 50 was granted on dt. 03.09.2005.

AND WHEREAS, the matter of shifting was placed before the SRC in its 387th meeting held on 24 – 25 August 2020. The committee considered the matter and decided to issue final show cause notice. Accordingly, a Final Show Cause Notice was issued to the institutor on 01.09.2020.

AND WHEREAS, the institution vide letter dt. 17.09.2020 has requested to Close the recognition granted to the institution for running D.T.Ed. course. The institution vide its letter stating as under: -

“As per reference sited above, we, the management of Sairam education trust, Sirkali Nagapattinam district, Tamilnadu would like to inform that we idle our Sairam Teacher Training Institute from the Academic Session 2019-20 due to poor admission rate of students. Also, our State Government Monitoring Authority SCERT, Through their letter communication 1731/e1/2019 advised us to stop admitting students due to eh fall in admission rate less than 30% of our intake.

So we, the management of Sai Ram Educational Trust, Sirkali, Nagapattinam District, Tamilnadu request your high office to allow us to idel D.T.Ed programme for upcoming three academic session. We will be resuming our communication with NCTE SRC when the admission flow of the students count retained well.”.

AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October 2020 and considered the matter as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee noted the request made by the institution vide letter dt 17.09.2020 to idle the course for next 3 academic session.

- 1. The SRC considered that there is no provision in NCTE Regulations, 2014 to treat upcoming session as idle.**

NOW THEREFORE, the Committee decided to **withdraw the recognition** granted to **Sai Ram College of Education, No. 14A, Pidari West Street, Sirkali, Nagapattinam District – 609110, TamilNadu** for conducting **D.T.Ed** course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through “online mode” available on NCTE’s website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE’s website.
