## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 ORDER

WHEREAS, Sri Sai Sirisha College of Education, Gandhinagar, Kasibugga, Srikakulam District – 532 222, Andhra Pradesh has submitted an application for grant of recognition for B.Ed. course and recognition was granted to the institution vide SRC order dated 19.04.2002.

AND WHEREAS, the SRC in its 178<sup>th</sup> meeting held on 13<sup>th</sup>-14<sup>th</sup> July, 2010 wherein the committee observed from records of the institution that the institutions were accorded recognition in the rented premises and they had not yet shifted to the permanent premises/building. In view of non-shifting of colleges to permanent building the committee decided to issue show cause notice u/s 17 of NCTE Act and obtain shifting fees and the documents for causing inspection for shifting.

AND WHEREAS, as per direction of Regional Committee Show Cause Notice was issued with request to submit relevant documents within 21 days of receipts of letter.

AND WHEREAS, the SRC in its 201<sup>st</sup> meeting held on 22<sup>nd</sup>-23<sup>rd</sup> February 2011 considered the matter and decided to withdraw recognition which failed to shift to permanent premises within the prescribed time limit of three years as per the norms, and also they had failed to respond to show cause notice issued by SRC, NCTE long back on 29.05.2009.

AND WHEREAS, as per the decision of SRC withdrawal order was issued to the institution on 07.04.2011.

AND WHEREAS, aggrieved by the withdraw order of SRC, the institution preferred an appeal to NCTE-Hqrs, the appellate authority order vide no. F.No. 89-412/2011Appeal/1<sup>st</sup> Meeting 2012 dated 15.02.2011, stated that "...the Council reached the conclusion that there was enough justification in remitting the matter to the SRC with a direction to cause inspection of the institution at the new premises within a month, after obtaining a payment of Rs. 40000/- from the institution and taking decision thereafter.

AND WHEREAS, the SRC in its 219<sup>th</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> March 2012 considered the Council order dt. 15/02/2012 and other relevant documents and decided to cause inspection at the new premises within a month after obtaining payment of Rs. 40000/- towards inspection fee, to examine whether the institution fulfils all the requirements as per the norms, for the proposed programme, subject to the condition that the deficiencies, if any, were duly rectified by the institution, under Section 14 (1) of NCTE Act.

**AND WHEREAS**, the inspection of the institution was fixed between 10<sup>th</sup> - 13<sup>th</sup> December 2012, the same was intimated to the institution on 04.12.2012. The inspection of the institution was conducted on 12.12.2012.

AND WHEREAS, the SRC in its 237<sup>th</sup> meeting held on 05<sup>th</sup>-06<sup>th</sup> January 2013, considered the VT report, VCD and all the relevant documentary evidences and it was decided to serve Show cause Notice under NCTE Act, for the following:

- Original certified copy of the land documents from Govt. authority is not submitted.
   Notarised English version of the certified copy land documents not submitted.
- Approved blue print of the building plan issued by competent civil authority is not submitted.
- As per copy of building plan, built up area of 1347.12 sq.mts is grossly inadequate for one unit of B.Ed course.
- As per copy of building plan, size of multipurpose hall is 103 sq.mts which is inadequate against the requirement of 2000 sq.ft.
- Original building completion certificate from competent Govt. engineer is not submitted. In the BCC submitted.
- As per building plan and BCC, building is stated to be located at Sy. No. 117/4
  alongwith other Sy. Nos., however, this Sy. No. has neither been mentioned in the
  affidavit nor any land document is submitted for this Sy. No.
- Notarised land usage certificate from the Revenue divisional office stating that the agriculture land converted to non-agriculture for the <u>educational purpose</u> is not submitted.
- Original FDRs of Rs. 5 & 3 lacs towards endowment and reserve fund from a Nationalised Bank in joint account is not submitted.
- Original up-to-date non encumbrance certificate is not submitted. In the photocopy of non encumbrance certificate, Sy. Nos. 118/3B & 118/16B are not appearing.
- College website address is not given.
- Sy No. 117/10 shown in the affidavit is not mentioned in BCC and building plan.
- Approved staff list from the affiliating body is not submitted.
- As per staff profile(s) submitted by the institution, principal is not eligible for the post, as he is not having P.Hd in Education.
- As per staff profile (s) submitted by the institution, salary to staff is being paid in cash as 'consolidated amount" which is not permissible at all.
- No staff profile has been countersigned by the principal.
- Staff profile of Smt. Toria Nirmala is not signed by the candidate itself.
- Lecturer (s) in Foundation/Fine Arts/Phy.Edu. are not appointed.

AND WHEREAS, a show cause notice was issued to the institution on 26.02.2013. The institution has submitted its written representation on 20.03.2013.

AND WHEREAS, the SRC in its 244<sup>th</sup> Meeting held on 09<sup>th</sup>-11<sup>th</sup> May, 2013 considered the written reply of the institution on the above matter and also the relevant documents of the institution and decided to withdraw recognition for the following reasons:-

- Notarized land usage certificate from the Revenue divisional office stating that the agriculture land converted to non-agriculture for the <u>educational purpose</u> is not submitted.
- Payment of salary to the staff is not being credited to Bank through Cheque.
- The institution has not appointed regular Principal with Ph.D qualification.
- · The institution is not having Website of its own.
- Survey numbers as mentioned in encumbrance certificate is not matching with other documents submitted.
- The institution has not submitted staff profile duly approved by competent authority.

AND WHEREAS, based on the above points the committee decides to withdraw the recognition of the B.Ed course run by the Sri Sai Sirisha College of Education, Gandhinagar, Kasibugga, Srikakulam District-532 222, Andhra Pradesh from the academic year 2013-14, in order to enable the ongoing batch of students in B.Ed, course, if any, to complete their course.

TAND WHEREAS, but it is made clear that the institution is debarred from making any further admission subsequent to the date of issue of this order. The Affiliating body / Examining board / body be informed accordingly.

AND WHEREAS, further decided to return Endowment funds and Reserve fund deposited with SRC NCTE, Bangalore, if any.

Now therefore recognition to Sri Sai Sirisha College of Education, Gandhinagar, Kasibugga, Srikakulam District - 532 222, Andhra Pradesh for the B.Ed Course in terms of section 14 (3) (b) of the NCTE Act, 1993, is hereby withdraw recognition with effect from 2013-14.

The original FDR's of Rs. 5.00 Lakhs and Rs. 3.00 Lakhs bearing nos. 115052 & 0844508 dated 30/08/2003 & 24/07/2009 from State Bank of India is hereby returned.

If the institution is not satisfied by the above Order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993, within 60 days from the date of this order.

Also ordered that a copy of this order be published in the Official Gazette.
