ORDER

WHEREAS, recognition was granted to the institution namely G.M.R. College of Education, No.25/417, C2-a, Saleem Nagar, R.S.Road, Nandyal, Kurnool-518501, Andhra Pradesh run by GM Institutions for Rural Development Health and Education Society, Nandyal, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2007-2008/13473 dt. 24.10.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. 21.01.2015 for its willingness for adherence of provisions of new Regulations.
- 3. AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of100 (Two basic units) from the academic session 2015-16.
- 4. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 28.02.2019. The institution vide letter dated 23.03.2019 submitted reply to the show cause notice. The SRC in its 378th meeting held on 25th & 26th July, 2019 considered the matter to issue Final Show Cause Notice.
- 5. AND WHEREAS, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 30.07.2019. The institution vide letter date 02.09.2019 submitted its reply to the Final Show Cause Notice. The institution submitted its reply vide letter dated 06.09.2019. The SRC in its 380th meeting held on 18th 19th September, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the Institution were carefully considered by the SRC and the following observations were

On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to G.M.R. College of Education, No.25/417, C2-a, Saleem Nagar, R.S.Road, Nandyal, Kurnool-518501, Andhra Pradesh for B.Ed programme for 2 units (50 students each unit).

- 6. NOW THEREFORE, this order is issued permitting the institution i.e. G.M.R. College of Education, Sy.No. 689/2C, 25 Ward, R.S.Road, Nandyal Municipality, Kurnool-518501, Andhra Pradesh run by GM Institutions for Rural Development Health and Education Society, Nandyal-518501, Andhra Pradesh for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (two units of 50 each subject) to fulfillment of the following conditions:
 - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:

- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
