WHEREAS, recognition was granted to the institution namely Sri Viswabharathi College of Teacher Training, Plot No.569/1, Giddalur Village & Post office, Giddalur Taluk & City, Prakasam District -523357, Andhra Pradesh run by Adarshavardhan Educational and Rural Development Society, Plot No.569/1, Kongalaveedu Road, Giddalur Village & Post office. Giddalur Taluk & City, PRakasam District-523357, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/SRCAPP14141/D.El.Ed/2016/85038 dt. 02.05.2016 for conducting B.Ed. course of two-year duration with 2 units of 50 students each from the academic session 2016-2017.

AND WHEREAS, the SRC received an email dated 11.09.2019 enclosing there with a copy of letter No. Lr.Rc.No.32/A/SCERT/2018-3 dated 09.09.2019 from Shri Sandhya Rani Kanneganti. Commissioner of School Education, School Education Department, Government of Andhra Pradesh stating therein the following:-

"...Sri. B. Purnchadra Reddy, Giddalur town, Prakasam District vide reference 1st read above have made a complaint against of Sri Viswabharathi College of Teacher Training, Gidlalur, Prakasam District stating that the Management got affiliation from school Education Department for conduct of D.El.Ed. Course by producing forged documents. Accordingly vide reference 2nd cited, the RJDSE, Guntur has been requested to conduct detailed enquiry in the matter and submit detailed report in the matter.

Thereby the Regional Joint Director of School Education Guntur vide his letter 3rd cited conducted enquiry in the matter and mentioned that on verification of the documents produced by the management as well as the genuineness furnished by the concerned local authorities, it is reported that the management has violated the guidelines and manipulated certain documents and suggested to take necessary action against the management as per rules.

Accordingly, vide reference 4th read above, a Show Cause Notice was issued to the Correspondent, Viswabharthi College of Teacher Training, Giddalur, Prakasam District and called for explanation as to why disciplinary action should not be initiated against their management for violation of guidelines and manipulation of certain documents and misleading the authorities for obtaining recognition and affiliation to their college. However, the management has not submitted any reply till date and thus failed to submit their explanation in the matter.

Since the management has not submitted their explanation to the Show Cause Notice issued by this office, the entire factual position has been submitted to Government vide reference 5th cited to issue necessary orders for cancelation of affiliation orders in respect of Srl Viswabharthi College of Teacher Training Giddalur, Prakasam Disrtrict as per Rule 11 in G.O.Ms.No.30 School Education (Prog.II) Department, dt. 08.07.2015 and also requested the Government to Inform the same NCTE to lodge criminal case against the management.

Accordingly, now the Government in their Memo 6th cited (copy enclosed) have issued orders and accorded permission to the Commissioner of School Education & Chairman

Accordingly, Sri Viswabharthi College of Teacher Training, Giddalur, Prakasam District is hereby withdrawal of affiliation in the reference 7th cited (copy enclosed) and also Regional Joint Director of School Education, Guntur was requested to file criminal case immediately against the Management of Sri Viswabharthi College of Teacher, Giddalur, Prakasam District for manipulation of documents to obtain recognition/affiliation from the respective authorities and sieze all the records of the College.

I request you to withdraw/cancel the permission/recognition to D.El.Ed. course run by Sri Viswabharathi College of Teacher Training, Giddalur, Prakasam District at early date."

AND WHEREAS, as per records the institution is also running B.Ed. programme. The original file of the B.Ed. programme being run by the Institution is also submitted before SRC. The SRC in its 380^{th} meeting held on $18^{th}-19^{th}$ September, 2019 considered the matter and decided as under;

The original files of the institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

(i) The Committee perused the letter No. Lr.Rc.No.32/A/SCERT/2018-3 dated 09.09.2019 received from the Commissioner of School Education, School Education Department, Government of Andhra Pradesh recommending withdraw/cancel the permission/recognition to D.El.Ed. course run by Sri Viswabharathi College of Teacher Training, Giddalur, Prakasam District . The Committee decided to withdraw the recognition granted to Sri Viswabhaarthi College of Education, Plot No. 569/1, Giddalur Village & Post office, Giddalur Taluk & City, Prakasam District-523357, Andhra Pradesh for conducting D.El.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the basis grounds mentioned in the letter dated 9.9.2019.

The Committee also decided to issue a Show Cause Notice the institution for the existing B.Ed progarmme of the Institution seeking clarification on the following:-

1. The institution is required to reply about the discrepancy/deficiency pointed out in the letter No. Lr.Rc.No.32/A/SCERT/2018-3 dated 09.09.2019 received from the Commissioner of School Education, School Education Department, Government of Andhra Pradesh.

2. The institution is required to submit following original documents:-

(i) Land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)

(ii) Land Use Certificate issued by the Competent Authority.

(iii) Original Non-Encumbrance Certificate issued by the Competent Authority. The institution is required to submit an attested/notarised copy of Non - Encumbrance Certificate issued by the Competent Authority.

(iv) Original approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an

exclusive earmarked building plan for each of the recognised Teacher Education programme)

(v) Original site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.

(vi) Original Building Completion Certificate issued by the competent authority.

3. The institution is required to submit original Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)

4. The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5

years alongwith a copy of the FDRs

9. The institution shall be required to submit an Affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details

(i) Details of land & building available at the time of recognition with the

Institution

(ii) Details of land & building now available with the Institution

(iii) Status of Management at the time of recognition and its present status In case of change of land & building or the Management at the time of recognition and thereafter the institution is required to specify the reason thereof with approval of the SRC, NCTE.

Therefore, the Committee decided to issue Show Cause Notice for B.Ed programme u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Show Cause Notice.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Sri Viswabharathi College of Education, Plot No.569/1, Giddalur Village & Post office, Giddalur Taluk & City, Prakasam District -523357, Andhra Pradesh run by Adarshavardhan Educational and Rural Development Society, Plot No.569/1, Kongalaveedu Road, Giddalur Village & Post office, Giddalur Taluk & City, Prakasam District-523357, Andhra Pradesh for conducting D.El.Ed programme of two years duration with an annual intake of 50 students (1 unit) on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
