WHEREAS, St. Joseph College of Education, Golden City, Kalakkad, Nanguneri Main Road, Kadamboduvalvu Post, Thirunelveli-627108, Tamilnadu was granted recognition for offering B.Ed course vide order no. F.SRO/NCTE/B.Ed./2006-2007/14083 dt.02.11.2007 of one year duration with an intake of 100 students.

AND WHEREAS, on 29.01.2015, the institution submitted an affidavit affirming adherence to Regulations, 2014. A revised provisional recognition order was issued to the institution on 01.05.2015 for offering B.Ed course of two years duration with an intake of 100 students (2 units of 50 students each) subject to fulfillment of certain conditions mentioned therein.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, Show Cause Notice was issued to the institution on 14.03.19. The institution has submitted a letter requesting for reduction in intake from 2 units to 1 unit in SRC office on 04.04.2019.

AND WHEREAS, the institution submitted a reply on 16.09.2019 & email dated 29.10.2019 in compliance of Show Cause Notice.

AND WHEREAS, the matter was finally considered by the SRC in its 381st meeting held from 31st October – 1st November, 2019 decided as under:-

"On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to St. Joseph College of Education, Golden City, Kalakkad, Nanguneri Main Road, Kadamboduvalvu Post, Thirunelveli-627108, Tamilnadu for B.Ed programme for 1 unit of 50 students."

NOW THEREFORE, this order is issued permitting the institution St. Joseph College of Education, Golden City, Kalakkad, Nanguneri Main Road, Kadamboduvalvu Post, Thirunelveli-627108, Tamilnadu run by The Nilgiris Diocesan Society, Udhagamandalam, Tamilnadu - 627108 for continuation of conducting B.Ed course of two years duration with an intake of 50 students (one basic unit) subject to fulfillment of the following conditions:

I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter:
 - The affidavit with enclosure submitted along with application.
 - The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 10.
- The institution shall fill the information on GIS Portal on the NCTE Website. 11.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
