WHEREAS, the recognition was granted to the institution namely Arunachalam Saraswathy Charitable Trust, No S- 76, 18th Street, Anna Nagar West, Chennai - 600040 run by A.S.College of Education, 25/1A, Nachlnamapatti Village, Doddampatti Post Office, Harur Taluk, 636903. Tamilnadu vide SRC (NCTE) order SRO/NCTE/SRCAPP13/B.Ed/TN/2015/62230 dt. 03.03.2015 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

AND WHEREAS, the institution vide letter dated 27.06.2018 received on 21.08.2019 requested for closure / withdrawal of B.Ed programme. The institution again requested vide letter dated 27.12.2018 to process the withdrawal of B.Ed course.

AND WHEREAS, the SRC in its 368th meeting held on 08th -09th January 2019 considered the matter and decided as under: -

"Have they completed the prescribed formalities? The agenda makes no mention. Resubmit properly".

AND WHEREAS, the formalities which are required to be done at the level of the institution have been informed vide letter dt. 13.2.2019.

AND WHEREAS, now, vide letter dt. 04.10.2019(P-421/Coors.) the institution had requested for closure of B.Ed. course and for the purpose the following documents have been submitted: -

1. NOC dt. 30.09.2019(P-420/Coors) issued by the Tamilnadu Teachers Education University.

AND WHEREAS, the matter was finally considered by the SRC in its 381st meeting 31st October - 1st November 2019 decided as under:-

The Committee decided that to withdraw the recognition granted to A.S.College of Education, 25/1A, Nachinamapatti Village, Doddampatti Post Office, Harur Taluk, Dharmapuri District -636903, Tamilnadu for conducting B.Ed. course under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 04.10.2019. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of A.S.College of Education, 25/1A, Nachinamapatti Village, Doddampatti Post Office, Harur Taluk, Dharmapuri District - 636903, Tamilnadu run by Arunachalam Saraswathy Charitable Trust, No S- 76, 18th Street, Anna Nagar West, Chennai - 600040 for conducting B.Ed programme of two years duration with an annual intake of 100 students (2 basic units) on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
