### ORDER

WHEREAS, recognition was granted to the institution namely Shantiniketan College of Education, Dupadu Village, Kallur Mandal, Kurnool-518218, Andhra Pradesh run by Shantiniketan Educational Society, Kurnool District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2007-2008/12112 dt. 26.09.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

- **2. AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 21.01.2015 for its willingness for adherence of provisions of new Regulations.
- **3. AND WHEREAS,** a Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of100 (Two basic units) from the academic session 2015-16.
- **4. AND WHEREAS,** the SRC in its 369<sup>th</sup>meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 05.02.2019. The institution vide letter dated 15.05.2019 submitted reply to the show cause notice. The SRC in its 379<sup>th</sup> meeting held on 21<sup>st</sup> 22<sup>nd</sup> August, 2019 considered the matter and decided to issue Final Show Cause Notice.
- **5. AND WHEREAS,** as per the decision of SRC a Final Show Cause Notice was issued to the institution on 29.08.2019. The institution vide letter date 01.10.2019 submitted its reply to the Final Show Cause Notice. The SRC in its  $382^{nd}$  meeting held on  $26^{th} 27^{th}$  November, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Shantiniketan College of Education, Dupadu Village, Kallur Mandal, Kurnool-518218, Andhra Pradesh for B.Ed programme for 2 units (50 students each).

- 6. NOW THEREFORE, this order is issued permitting the institution i.e. Shantiniketan College of Education, Survey No. 50,62 & 63, Dupadu Village, Laxmipuram Gram Panchayath, Kallur Mandal, Kurnool District-518218, Andhra Pradesh run by Shantiniketan Educational Society, Dupadu (V), Kallur (M), Kurnool District, Andhra Pradesh for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (two units) of 50 each subject to fulfillment of the following conditions:
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
