ORDER

WHEREAS, the recognition was granted to the institution namely **Modern College of Education, 5-2/2, Ghatkesar Mandal, Rangareddy District-501301, Andhra Pradesh** run by **Modern Educational Society, 1-5-269, Zamistanpur, Hyderabad-20, Andhra Pradesh** vide SRC (NCTE) order no. F.AP/NEW/B.Ed/81/SRO/NCTE/2002-2003/6680 dt. 04.04.2003 (P-693/Coors.) for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

2. **AND WHEREAS**, the institution was granted recognition on **04.04.2003** with a condition that the institution shall shift to its own premises/building within three years from the date of recognition (in case the course is started in rented premises).

3. **AND WHEREAS**, the institution submitted shifting proposal along with DD of Rs.40,000/- bearing No.037766 dated 24.09.2007 on 26.09.2007.

4. **AND WHEREAS**, a letter was sent to the institution on 25.05.2009 regarding submission of all documents. The institution submitted the affidavit for offering B.Ed course with an intake of 100 students on 04.02.2015. A revised order was issued to the institution on 11.05.2015 for two basic units of 50 students each with shifting condition. The Minority Welfare Department, Government of Telangana sent minority certificate dated 28.08.2015 on 07.09.2015 in r/o of the institution for the session 2015-16.

5. **AND WHEREAS**, the institution submitted its written representation on 03.08.2015 along with relevant documents informing that it has already shifted to its own premises from 2006-07. The document submitted by the institution were processed and placed before SRC in its 315th meeting held on 17th-18th June, 2016. The Committee considered and decided to issue a letter. As per the decision of SRC, a letter (inspection intimation) was sent to the institution on 13.07.2016.

6. **AND WHEREAS**, as per the directions of SRC, inspection of the institution was conducted on 22.08.2016 and the VT Report along relevant documents received in the office of SRC on 26.08.2016. The SRC in its 321st meeting held on 28th & 29th September, 2016 considered the VT report decided to issue SCN.

7. **AND WHEREAS**, as per the decision of SRC, a show cause notice was issued to the institution on 24.10.2016. The institution vide letter dated 16.11.2016, followed another letter received on 05.07.2019 submitted its reply to the show cause notice.

8. **AND WHEREAS**, the SRC in its 378th meeting held on 25th & 26th July, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 30.07.2019. The institution vide letter dated nil received on 20.08.2019 & 06.01.2019 reply to Final Show Cause Notice. The SRC in its 383rd meeting held on 07th to 09th considered the matter and decided as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the Visiting Report and subsequent reply submitted by the Institution and decided to **permit the institution to shift its building at new premises**. Further, on the perusal of the reply, documents and records submitted by the Institution, Committee also decided that the **continuation order** be issued to the Institution Modern College of Education, Telangana for **B.Ed programme for 2 basic units (50 students each unit)**.

9. **NOW THEREFORE**, this order is issued permitting the institution i.e. Modern College of Education, 5-2/2, Ghatkesar Mandal, Rangareddy District-501301, Andhra Pradesh **to shift its building at new address** at Sy. No. 7, Door No. 1-36 Gandhi Nagar, Ghatkesar, Ranga Reddy District, Telangana run by **Modern Educational Society, Musherabad, Hyderabad, Telangana** for continuation of recognition for B.Ed course of two years duration with an intake of (two units) of 50 students each subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

11. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

14. The institution shall make available the list of students admitted on its official website.

15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
