WHEREAS, the recognition was granted to the institution namely, Sri Venkateshwara College of Education, Cuddapah Revenue Division 5/152, 5/153, Ravindra Nagar Cuddapah District, Andhra Pradesh-516003 vide SRC vide order no. F.AP/SEC/NEW /59/SRO/NCTE/2002-2003/7971 dt. 03.07.2003 for (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 24.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units** from the academic session 2015-16.
- 3. AND WHEREAS, a corrigendum was issued to the institution vide order no. F.SRO/NCTE/APS00006/B.Ed./AP/2015-16/82093 on 19.02.2016 for grants recognition to Sri Venkateshwara College of Education, Cuddapah Revenue Division 5/152, 5/153, Ravindra Nagar Cuddapah District, Andhra Pradesh-516003 for conducting B.Ed. Programme of two years duration with an annual intake of 50 students each (two basic units) from the academic session 2015-2016.
- **4. AND WHEREAS,** the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue First SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, as per decision of SRC First Show Cause Notice was issued to the institution on 06.11, 2019. The institution did not submit reply to the Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 393^{rd} meeting held on $05^{th}-06^{th}$ January 2021, decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 08.01.2021. The institution submitted reply received on 01.02.2021.
- **6. AND WHEREAS,** the SRC in its 399th Meeting held on 15th & 16th June 2021 considered the matter and to issue last reminder (Letter). Accordingly, as per decision of SRC a last reminder letter was issued to the institution on 01.07.2021. The institution has not submitted reply to the last reminder letter.
- 7. **AND WHEREAS,** the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Last Reminder (Letter) on 01.07.2021. The institution failed to submit reply to the Last Reminder (Letter).

Hence, the Committee decided to withdraw the recognition granted to Sri Venkateshwara College of Education, Cuddapah Revenue Division 5/152, 5/153, Revindra Nagar, Cuddapa District-516003, Andhra Pradesh for conducting B.Ed. programmewith effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee thereby withdraws recognition granted to Sri Venkateshwara College of Education, Cuddapah Revenue Division 5/152, 5/153, Revindra Nagar, Cuddapa District-516003, Andhra Pradesh run by Sri Venkateshwara Educational Society, 5/152, 5/153, Ravindra Nagar, Cuddapah, Andhra Pradesh-516003 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2021-2022 onwards.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
