## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, Azeezia College of Nalgonda District, Andhra Pradesh vide SRC vide order no. F.AP/SEC/NEW/264/SRO/NCTE/2002-2003/6651 dt. 04.04.2003 for (B.Ed.) course of oneyear duration with an annual intake of 100 students from the academic session 2002-2003.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 02.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- AND WHEREAS, the SRC in its 315th Meeting held on 17th & 18th June 2016 considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 12.07.2016. The institution has submitted a written representation on 17.08.2016.
- AND WHEREAS, the SRC in its 323rd meeting held on 16th-18th November 2016 considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC Show Cause Notice was issued on 08.12.2016. The institution did not submit reply to Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 381st meeting held on 31st October-01st November 2020 wherein general decision was taken that the Show Cause Notice be issued to the institutions those have not submitted any reply to the earlier notices or RPRO Compliance. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 15.12.2020. The institution did not submit any reply to Show Cause Notice.
- AND WHEREAS, the SRC in its 399th Meeting held on 15th & 16th June 2021 considered the matter and decided issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued on 02.07.2021. The institution did not submitted reply to Final Show Cause Notice.
- AND WHEREAS, the SRC in its 402<sup>nd</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> September, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN) on 02.07.2021. The institution failed to submit reply to the Final Show Cause Notice.

Hence, the Committee decided to withdraw the recognition granted to Azeezia college of Education, Nalgonda Revenue Division, 5-8-175, Munian Chalka, Nalgonda District – 508001, Telangana for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Azeezia college of Education, Nalgonda Revenue Division, 5-8-175, Munian Chalka, Nalgonda District 508001, Telangana run by Azeezia Educational & Welfare Society, Nalgonda District, Telangana for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2021-2022 onwards.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

**10.** Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
