ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Mahamood Educational and Welfare Society, Plot No. 1/281-3, Sai Baba Nagar, Akkayapalli Village, Ravindra Nagar Post Office, Kadapa Taluka, Kadapa District – 516003, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE in the name of Mahamood B.Ed College, Plot No. 5337, Street No. 1/287-8, Akkayapalli Village, Ravindra Nagar Post Office, Kadapa Taluka, Kadapa District – 516003, Andhra Pradesh for seeking grant of recognition for conducting B.Ed Course of one year duration, through online on 30.09.2010.

The Application was scrutinized and a copy of application was sent to State Government for recommendation on 09.11.2010 / 02.02.2011. A deficiency letter was issued to the institution on 10.12.2010.

AND WHEREAS, the Committee in its 202nd Meeting held on 14th – 15th March 2011 considered the reply of institution dt. 15.02.2011 for the deficiencies and decided to cause inspection of the institution under Section 14 of NCTE Act to verify the infrastructural and instructional facilities.

AND WHEREAS, the inspection of the institution was done on 29.03.2011.

AND WHEREAS, the Committee in its 204th Meeting of SRC held on 27th – 28th April 2011 considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve the Show cause Notice for the following:

1. The total built up area as per VT report is 21814 sq.ft, where as in Building Completion Certificate it is 22753 sq.ft. This discrepancy may be explained.
2. Approved building plan from competent authority is to be submitted.
3. Building completion certified from competent Govt. Engineer is to be submitted.
4. Land documents, building plan and building completion certificate shows Sy.No. as 200, where as inspection was conducted at No. 5337.
5. Certified copy of registered land document issued by competent authority is to be submitted.
6. Notarised copy of Land usage certificate issued by competent authority is to be submitted.
7. The Affidavit in Rs. 100/- stamp paper in the prescribed format with Notary attestation to be submitted.

AND WHEREAS, as per direction of SRC, Show Cause Notice was issued to the institution on 25.05.2010. In response to this office letter dated 25.05.2010 the institution has submitted reply vide letter dated 03.06.2011, explaining/clarifying with evidence, on the points raised in the show cause notice.

AND WHEREAS, on careful perusal of the original file of the institution, VT Reports and other related documents, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time laid on the table and the reply to the show cause notice, the Regional Committee in its 208th Meeting of SRC held on 31st July 2011 decided to issue Letter of Intent for grant of recognition to B.Ed course of One year duration with an annual intake of 100(One Hundred only)(one unit) from the academic year 2011-12 subject to the genuineness of minority certificate and clarification from Principal Secretary Andhra Pradesh on minority certificate in the name of the institution & appointment of qualified staff through duly constituted selection committee as per the Norms of NCTE/State Government/Affiliating University and be given effect before the commencement of the academic session.

AND WHEREAS, a letter of intent was issued to the institution on 20.07.2011. The institution submitted in its reply on 27.07.2011. SRC considered the reply submitted by the institution in 209th Meeting held on 31st July 2011 and decided that Formal Recognition be granted to B.Ed., course of one year duration with an annual intake of 100 (One hundred only) students, subject to submission of valid/renewed minority status certificate & rectification of deficiencies in staff list, if any.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Mahamood B.Ed College, Plot No. 5337, Street No. 1/287-8, Akkayapalli Village, Ravindra Nagar Post Office, Kadapa Taluka, Kadapa District – 516003, Andhra Pradesh for conducting B.Ed Course of one year duration with an annual intake of 100 (Hundred) students from the academic session 2011-2012 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject, to fulfillment of the following conditions:

- I. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
- IV. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- V. The institution shall declare themselves as minority trust and minority institution proposed to be established.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

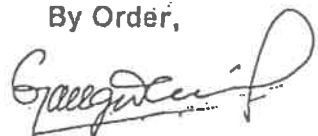
The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
