CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Mother Teresa College of Education, Warangal District, Andhra Pradesh run by Mother Teresa Educational Society, Mahabubabad, Warangal District, Andhra Pradesh vide SRC (NCTE) order No. F.APNEW/B.Ed/121/SRO/NCTE/2002-2003/6683 dated 08.04.2003 for B.Ed. Course of one-year duration from the academic session 2002-2003 with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 22.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 02.07.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- AND WHEREAS, the institution vide its letter dated 30.10.2015 has made a request for reduction of intake from existing 2 units to 1 unit. The above request was placed before the SRC in its 342rd meeting held on 05th - 06th July 2017. The Committee considered the matter and decided to permit 1 unit subject to submit the documents mentioned therein. Accordingly, an order was issued to the institution on 09.08.2017.
- AND WHEREAS, the matter of not shifting to its own permanent building as the initial recognition was granted to the institution on rented premises with a condition that the institution shall shift to its own premises within three years from the date of recognition was considered by the SRC in its 387 meeting held on 24th - 25th August 2020 wherein general decision was taken that the Show Cause Notice be issued to the institutions those have not submitted any reply to the earlier notices or RPRO compliance. Accordingly, another Show Cause Notice was issued to the institution on 15.12 2020. The institution has submitted its reply on 20.01.2021.
- AND WHEREAS, the SRC in its 395th meeting held on 25th 26th February, 2021 considered the matter and decided to issue shifting order. Accordingly shifting order was issued to the institution to shift its new premises "Mother Teresa College of Education, Plot No. 137/A, 138/A, 137/B, 150, 152, Yellandu Road, Mahabubabad Post, Warangal District 605101, Andhra Pradesh" vide order No.SRC/NCTE/APS00205/B.Ed/TS/2021/25004-5011 dated 15.03.2021. The institution vide letter dated 15.03.2021 submitted reply though the SRC NCTE website.
- AND WHEREAS, the SRC in its 397th meeting held on 24th 25th March, 2021 considered the matter and decided as under:-

- 7. NOW THEREFORE, this order is issued permitting the institution i.e. Mother Teresa College of Education, Survey No. 137/A, 137/B, 138/A, 150/ 152, Old Abadi, Yellandu Road, Mahabubnagar, Warangal District 506101, Telangana run by Mother Teresa Educational Society, Mahabubabad, Warangal District-506101, Telangana for continuation of recognition for B.Ed. course of two years duration with an intake of 50 students (1 basic unit) of subject to fulfillment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 9. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned.
