WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, GSR DEd College For Girls, Plot No.222/A, NRT Road, Brahmanapalli Village, Vinukonda P.O, Taluk & City, Guntur District-522647, Andhra Pradesh run by GSR Educational & Rural Development Society, Plot No. 2-96, Main Bazar Road, Vinukonda Village & P.O, Vinukonda Taluk & City, Guntur District-522647, Andhra Pradesh for D.El.Ed. & D.El.Ed-Al programme as per following details:-

- (i) The SRC vide order no. F.No.SRCAPP616/D.El.Ed/AP/2012-13/44343 dt. 26.07.2012 for conducting D.El.Ed. course of two-year duration with an annual intake of 50 students from the academic sessions 2012-2013.
- (ii) The SRC vide order No. F.SRO/NCTE/SRCAPP2443/D.El.Ed-AI/AP/2016-2017/82926 dated 03.03.2016 for conducting D.El.Ed-Al. course of two-year duration with an annual intake of 100 students (2 units) from the academic sessions 2016-2017.

AND WHEREAS, a letter No. RC. No. 359/A/SCERT/2019 dated 29.06.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for de-recognition order in respect of 188 Pvt. D.El.Ed Colleges in A.P. since the said managements of Pvt. D.El.Ed Colleges have made admission into the D.El.Ed Course during academic year 2018-19 on their own in violation of Government orders.

AND WHEREAS, the matter was considered by SRC in its 388th meeting held on 14th-15th September 2020 and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 21.09.2020. Therefore, the institution vide letter dated 23.02.2021 submitted its written representation.

AND WHEREAS, the SRC in its 397th Meeting held on 25th & 26th March 2021 and considered the matter as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution by its letter dated 23.02.2021 by withdrawing the recognition granted to GSR D.Ed College for Girls, Khasara No. 222/A, 222/B, NRT Road, Brahmanpalli Village, Vinukonda Post Office, Vinukonda Taluka and City, Guntur District-522647, Andhra Pradesh for conducting D.El.Ed., D.El.Ed-Al course under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.

(c) Resolution of the management to the effect for closure of the course."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to GSR DEd College For Girls, Plot No.222/A, NRT Road, Brahmanapalli Village, Vinukonda P.O, Taluk & City, Guntur District-522647, Andhra Pradesh run by GSR Educational & Rural Development Society, Plot No. 2-96, Main Bazar Road, Vinukonda Village & P.O, Vinukonda Taluk & City, Guntur District-522647, Andhra Pradesh for conducting D.EI.Ed. & D.EI.Ed.-AI course of two years duration with an annual intake of 50 students for (D.EI.Ed.) & 100 students (2 units) for (D.EI.Ed.-AI) course with effect from the next academic session i.e. 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
