### WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the Holy Flowers Teacher Training Institute, Madukarai Main Road, Kariyamanickam, Pondicherry (i)Vide SRC (NCTE) order No.PN/ELE/SRO/NCTE/2005-2006/4127 dt. 22.11.2005(D.T.Ed. Elementary)(ii)Vide SRC (NCTE) F SRO/NCTE/D T.Ed/Al/2006-2007/10534 dt.03.02.2007for conducting. (D.T.EdAdditional Intake) course of two-year duration with an annual intake of 50 students on 22.11.2008. from the academic session 2005-2006 and (50 additional intake) total intake of 100 students on 03.02.2007.

- 2. AND WHEREAS, the matter was further considered by the SRC in 388<sup>th</sup> meeting held on 14<sup>th</sup> -15<sup>th</sup>September2020 and Committee decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on 16.10.2020 to reply within 21 days. The institution has not submitted any compliance against Final Show Cause Notice.
- 3. AND WHEREAS, the matter was further considered by the SRC in its 397<sup>th</sup> meeting held on 25<sup>th</sup>& 26<sup>th</sup> March 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

(i) A Final Show Cause Notice was issue to the institution on 16.10.2020. the institution has not submitted Final Show Cause Notice Reply.

Hence, the Committee decided to withdraw the recognition granted to Devaraj College of Education, Holy Flower Educational Society, #41, S. No. 210/11, 211/2,210/13,211/4, Madakarai Main Road, Kariamanikkam, Pondicherry-605106, Pondicherry for conducting B.Ed., (D.T.Ed) Elementary, &D.T.Ed (Additional Intake) course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Holy Flower Educational Society, #41, S. No. 210/11, 211/2,210/13,211/4, Madakarai Main Road, Kariamanikkam, Pondicherry-605106, Pondicherryfor conducting D.T.Ed.(Elementary)&D.T.Ed. (Additional Intake)course with effect from academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.
- 5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution

offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
