WHEREAS, the institution namely, PSG College of Education, Palanisami Gounder Thottam, Tiruchengodu Road, Sankari-636301, Salem District, Tamilnadu was granted recognition for offering B.Ed course vide SRC NCTE's order dated 30.12.2005 of one year duration with an intake of 100 students.

AND WHEREAS, on 19.1.2015, the institution submitted an affidavit affirming adherence to Regulations, 2014. A revised provisional recognition order was issued to the institution on 30.04.2015 for offering B.Ed course of two years duration with an intake of 100 students (2 units of 50 students each) subject to fulfillment of certain conditions mentioned therein.

AND WHEREAS, the matter was placed before in 314th meeting of SRC held on 27th & 28th May, 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on 13.06.2016 but the inspection was not carried out.

AND WHEREAS, the institution vide letter dt. 29.10.2015 submitted compliance / documents of RPRO.

AND WHEREAS, the above matter was placed before the SRC in its 375^{th} meeting held on 13^{th} – 14^{th} May 2019 and the Committee decided to withdraw the recognition. Accordingly, a withdrawal order was issued on 04.06.2019 vide order no. F.SRC/NCTE/APSO3886 / 104884 – 888.

AND WHEREAS, the SRC received an order on 24.12.2019 from the Appellate Authority (HQ) vide order no. F.No. 89-333/E-130251/2019 Appeal/38th Mtg.-2019/28th November 2019 / 86565 dated 23.12.2019.

AND WHEREAS, after perusal of the Memoranda of Appeal, affidavit documents on record & oral arguments advanced during the hearing, Appeal Committee concluded to set aside the impugned order of withdrawal dated 04.06.2019. SRC is required to revisit the matter afresh.

AND WHEREAS, the above matter was placed before the SRC in its 383rd meeting held on 07 -09 January 2020. The Committee considered the matter and decided to issue Final Show Cause Notice to the institution to submit the written representation against the conditions mentioned therein.

AND WHEREAS, a Final Show Cause Notice was issued on 21.01.2020. The institution has submitted its reply on 07.09.2020.

AND WHEREAS, the matter was finally considered by the SRC in its 388^{th} Virtual Meeting held from 14^{th} – 15^{th} September 2020 decided as under: -

"On the perusal of the reply submitted by the institution vide letter dt. 08.08.2020, the Committee decided that the **continuation order** be issued to the Institution **PSG College of Education, Salem District, Tamilnadu** for **B.Ed** programme for **2 basic unit of 50 students.**"

NOW THEREFORE, this order is issued permitting the institution PSG College of Education, 178/2D1A, Town Panchayat Palanisami Gounder Thottam, Tiruchengodu Road, Sankari-636301, Salem District, Tamilnadu run by Palanisamy Gounder Charitable Trust, 1-15-22M1, Shanmuga Complex, New Edappadi Road, Sankari-637301, Salem District, Tamilandu for continuation of conducting B.Ed course of two years duration with an annual intake of 2 basic units (50 students each unit) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 5. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information regarding the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - q. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 10. The institution shall make available the list of students admitted on its official website.
- 11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
