ORDER

WHEREAS, the recognition was granted to the institution namely J.V.R.R. Memorial College of Education, Lakshmikantha Reddy Estate, Railway Station Road, Nandyal-518502, Andhra Pradesh vide SRC (NCTE) order no. F.AP/B.Ed/Ext/44/SRO/NCTE/2000-2001/1595 dt. 16.08.2000 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 09.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter, provisional revised recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 06.03.2019. The institution vide letter dated 22.03.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 376th meeting held on 11th & 12th June, 2019 considered the matter and decided as under:

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to withdraw the recognition granted to J.V.R.R. Memorial College of Education, Lakshmikantha Reddy Estate, Railway Station Road, Nandyal-518502, Andhra Pradesh for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the following grounds:-

1. Latest faculty list duly approved by the competent authority not submitted
2. The details in the EC and the location of the college is not matching.
3. The land document is not clearly registered in the name of society rather it is a gift deed.
4. No exclusive building is shown for Teacher Education.
5. Land Conversion Certificate is not in favor of institution rather is in the individual name.

AND WHEREAS, as per the decision of SRC a vide withdrawal order no. F.SRO/NCTE/APSO0282/B.Ed/AP/2019/106721-6726 dated 10.07.2019 was issued to the institution.

Aggrieved with the order of the SRC, the institution filed a W.P.No. 7428 of 2019 titled as J.V.R.R. Memorial College of Education Vs. NCTE and others before the Hon'ble Court of Delhi. The SRC in its 378th meeting held on 25th – 26th July, 2019 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- (i) The Committee noted that the impugned decision taken by the SRC regarding withdrawal of recognition of the Institution has been stayed by the Hon'ble High Court at New Delhi and the operative part of the Hon'ble Court is as under:-

“..The counter affidavit be filed within a period of four weeks.

Till the next date of hearing the operation of the impugned decision to be taken under Section 17(1) of the NCTE Act, 1993 to withdraw the recognition granted to the petitioner is stayed.”

The Committee decided that the compliance of Hon'ble Court order be made and inform all the concerned about staying of withdrawal order by the Hon'ble High Court.

The Committee also decided that a counter affidavit in the case be filed for vacation of the stay and disposal of the case.

In view of the above, all concerned are directed to make compliance of the order of the Hon'ble High Court staying withdrawal order of the SRC order No. F.SRO/NCTE/APSO0282/B.Ed/AP/2019/106721-6726 dated 10.07.2019 till further orders.
