ORDER

WHEREAS, the recognition was granted to the institution namely **G.V.R & S College of Education, Chandramouli Nagar, Ring Road, Guntur-522007, Andhra Pradesh** run by **Sri Gangineni Vinkateswara Rao & Sailaja Educational Society, Guntur, Andhra Pradesh** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/4161 dt. 14.06.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

2. AND WHEREAS, on 31.12.2014, a letters were issued to all existing institutions regarding notification of new Regulations 2014 seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015. On 31.01.2015, the institution has submitted the affidavit for offering B.Ed course with an intake of 100 students.

3. AND WHEREAS, the SRC in its 276th meeting held on 7th-9th January, 2015 decided to issue provisional recognition orders to the existing institutions and the committee also decided to maintain a check list of such cases for verification in October/November and for causing inspection. Accordingly, as per the Regulation 2014 a revised recognition order was issued to the institution on **06.05.2015** with an annual intake two basic units of 50 students each with a condition that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds.

4. AND WHEREAS, the SRC in its 318th meeting held on 8th & 9th August, 2016 considered the matter and decided as under;

1. In this case, a RPRO was issued for B.Ed (2 Units). The College has requested for reduction of intake from 2 units to 1 unit.
2. The request is accepted. Issue a revised FR for B.Ed (1 unit) w.e.f. 2016-17.
3. In view of the reduction in intake, there is no need for an inspection to check adequacy of facilities. Therefore, cancel the VT inspection ordered.
4. Since the intake has been reduced, there will be no scope for fresh admission at this state. Ask the College not to make fresh admissions in 2016-17.
5. Inform the affiliating body accordingly.

5. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a show cause notice was issued to the institution on 25.04.2019. The institution vide letter dated 24.05.2019 submitted reply to the show cause notice. The SRC in its 378th meeting held on 25th & 26th July, 2019 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC a Final Show

Cause Notice was issued to the institution on 30.07.2019. The institution vide letter date 14.01.2020 submitted its reply to the Final Show Cause Notice.

6. **AND WHEREAS**, the SRC in its 384th meeting held on 12th – 13th February, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply, documents and records submitted by the Institution, Committee decided that the **continuation order** be issued to the Institution **G.V.R & S College of Education, Guntur-522007, Andhra Pradesh** for B.Ed programme for 1 basic unit of 50 students.

7. **NOW THEREFORE**, this order is issued permitting the institution i.e. **G.V.R & S College of Education, Sy. No. 904/3, Ring Road, Guntur Town, Guntur District-522007, Andhra Pradesh** run by **Sri Gangineni Vinkateswara Rao & Sailaja Educational Society, Sy. No. 904/3, Ring Road, Guntur Town, Guntur District-522007, Andhra Pradesh** for continuation of recognition for B.Ed course of two years duration with an intake of 50 students (one unit) of subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of

the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

12. The institution shall make available the list of students admitted on its official website.

13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
