**Withdrawal Order**

Whereas, the recognition was granted to the institution namely **S. Veeraswamy Chettiyar Institute of Teacher Education, S.V. Nagar, Puliangudi, Tirunelveli District – 627855, Tamilnadu** was granted recognition vide SRC (NCTE) order no. F.TN/ELE/SRO/NCTE/2005-2006 / 4058 dt. 17.11.2005 for conducting **D.T.Ed. course** of two-years duration with an annual intake of 50 students.

And Whereas, the institution was granted recognition for additional intake of 50 students for conducting **D.T.Ed course** vide order no. F.SRO/NCTE/D.T.Ed.-AI/2006-2007 / 5027 dated 20.06.2007 in (APS07387).

And Whereas, Now, the institution has requested to surrender one unit of D.T.Ed. course vide email dated 08.11.2019.

And Whereas, SRC in its 384<sup>th</sup> meeting held on 12<sup>th</sup> & 13<sup>th</sup> February 2020 and considered the matter as under:

“The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee decided that to withdraw the recognition granted to **S. Veeraswamy Chettiyar Institute of Teacher Education, S.V. Nagar, Puliangudi, Tirunelveli District – 627855, Tamilnadu** for conducting **D.T.Ed. (Add. Intake) (APS07387) course** under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 08.11.2019. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course.”

Now therefore, in exercise of the powers vested u/s 17 (1) of the NCTE Act, 1993, the Southern Regional Committee hereby **withdraws recognition** granted to **S. Veeraswamy Chettiyar Institute of Teacher Education, S.V. Nagar, Puliangudi, Tirunelveli District – 627855, Tamilnadu** for conducting **D.T.Ed. course** of two-years duration with an annual intake of 50 students on the grounds mentioned above. The withdrawal of recognition is effective from the academic session commences next to issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through “online mode” available on NCTE’s website [www.ncte-india.org](http://www.ncte-india.org), with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE’s website.
