ORDER

Whereas, the institution namely **M.E.T College of Education, No. 13/142-B, Poigai Dam Road, Chenbagaramanputhur & Post, Kanyakumari District, Tamilnadu-629304** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/M.Ed./2006-2007/13734 dt. 31.10.2007 for conducting **M.Ed. course** of one-year duration with an annual intake of 25 students.

Now therefore, enhancement of intake of 10 seats from existing 25 to 35 is permitted to **M.E.T College of Education, No. 13/142-B, Poigai Dam Road, Chenbagaramanputhur & Post, Kanyakumari District, Tamilnadu-629304** for M.Ed. course dt. 01.09.2010 for the session 2010-2011.

And Whereas, after promulgation of NCTE Regulations, 2014, the institution submitted a notarized affidavit dt. 19.01.2015.

And Whereas, the Southern Regional Committee (NCTE) issued the revised provisional recognition order dt. 25.05.2015 for conducting **B.Ed. course** of two years duration with an annual intake of **50 students (one unit)**.

And Whereas, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th Meeting held on 28.01.2019 and the Committee decided to issued Show Cause Notice and Show Cause Notice was issued to the institution on dt. 23.10.2019.

And Whereas, the institution submitted compliance against the Final Show Cause Notice reply on dt. 25.11.2019.

And Whereas, the institution submitted compliance against Final Show Cause Notice on 25.11.2019 which was considered by the SRC in its 384th Meeting held on 12th & 13th February 2020 as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the original documents and records made available in the file. The Committee decided that the continuation orders be issued to M.E.T College of Education, No. 357-C, Opp. Dr. Naidu Hospital, Railway Station Road, Kottar P.O., Nagercoil, Kanyakumari District, Tamilnadu for following existing courses:

- (i) *B.Ed. for 2 units (50 students each unit).*
- (ii) *M.Ed. for 1 unit of 50 students.”*

Now Therefore, the SRC decided to permit the institution i.e. **M.E.T Teacher Training Institute, No. 82/7, 8, 9, Near Samatwapuram, Poigai Dam Road, Chembakaraman Puthoor, Kanyakumari District, Tamilnadu-629002** for M.Ed. course run by **Mogals Educational and Charitable (M.E.T College of Education), No. 357/C, Opp. Dr. Naidu Hospital, Railway Station Road, Kottar P.O., Nagercoil, Kanyakumari District, Tamilnadu-629002** for continuation of recognition for M.Ed. course of two-years duration with an intake of 50 students (one unit) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
 - 9. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
 - 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
 - a. Sanctioned programme(s) along with annual intake in the institution:

- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
12. The institution shall make available the list of students admitted on its official website.
13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
