WHEREAS, recognition u/s15 Act of NCTE, 1993 was granted to the institution namely, R.V.R.R. College of Elementary Education, JKL. College Road, Pattachipuram Post, Guntur - 522006, Andhra Pradesh vide order No. F.SRC/NCTE/D.Ed./2005-2006/2268 dated 05.08.2005 for conducting Elementary (D.Ed.) Course of two year duration with an annual intake of 50 students.

AND WHEREAS, the institution vide letter dated 18.08.2022 has submitted request 2. to close the M.Ed. Programme. The SRC in its 413th Meeting held on 22nd - 23rd August, 2022 considered the request for close the D.Ed. Programme matter and decided as under: -

The Committee agreed to close down the D.Ed. programme as requested by the Management vide letter dated 18.08.2022 by withdrawing the recognition granted to R.V.R.R. College of Elementary Education, J.K.C College Road, Pattabhipuram Post Guntur - 522006, Andhra Pradesh for conducting D.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting.

- NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Rayapati Venkatta Ranga Rao College of Education, JKC College Road, Guntur - 522006, Andhra Pradesh for conducting Elementary D.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) with effect from the end of next academic session i.e., 2022-2023. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn.
- Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."
