#### **CONTINUATION ORDER**

WHEREAS, the recognition was granted to the institution namely, Sree Sai Siddartha College of Education, k.v.Reddy Nagar, OPP S.L.V.Talkies, Tadipatri, Anantapur-515411, Andhra Pradesh vide order no. F.SRO/NCTE/B.Ed./2006-2007/685 dt. 12.04.2007 for conducting Secondary (B.Ed.) Course of One year duration with an annual intake of 100 students from the academic session 2006-2007.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated 21.01.2015 and the revised provisional recognition order was issued to the institution on 13.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, on the basis of request, the SRC in its  $342^{nd}$  meeting held on  $5^{th} 6^{th}$  July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, a order was issued to the institution on 21.07.2017 reduction of intake from 2 units to 1 unit.
- 4. AND WHEREAS, the SRC in its 369<sup>th</sup> Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 09.04.2019. The institution has not submitted reply to the Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 381st meeting held on 31St Oct & 01st Nov, 2019 has considered the matter and the decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issue by the SRC. Accordingly, a Final Show Cause Notice was issued to the institution on 15.11.2019. The institution has not submitted reply to the Final Show Cause Notice.
- **6. AND WHEREAS,** the SRC in its 395<sup>th</sup> meeting held on 25<sup>th</sup> 26<sup>th</sup> February 2021 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No. F.SRO/NCTE/APS07094/B.Ed./AP/395<sup>th</sup>/2021/124972-4979 dt.15.03.2021 was issued to the institution.
- 7. **AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No.89-174/E-/186248/2021 Appeal/18<sup>th</sup> Meeting, 2021 Appeal No.APPLSRC202114041 dated 02.09.2021 appeal remand back the order appealed against. The institution has submitted reply on 16.10.2021.

- **8. AND WHEREAS,** the SRC in its  $404^{th}$  meeting held on  $16^{th}$   $17^{th}$  November, 2021 has considered the matter and decided to constitute VT. The inspection conducted on  $18^{th}$   $19^{th}$  December, 2021 and VT report was received on 21.12.2021.
- **9. AND WHEREAS,** the SRC in its 406<sup>th</sup> Meeting held on 19<sup>th</sup> January, 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution namely Sree Sai Siddartha College of Education decided that shifting of premises be permitted to the institution at new address i.e. Survey No. 1233-3, Peddapolamada Village Land Ravi Venkatampalli Village, Yerraguntapalli Gram Panchayat, Tadipatri (M), Anantapuramu District-515411, Andhra Pradesh. The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 1 basic unit of 50 students".

- 10. NOW THEREFORE, this order is issued permitting the institution i.e., Sree Sai Siddartha College of Education to shift its building at new address at Survey No. 1233-3, Peddapolamada Village Land Ravi Venkatampalli Village, Yerraguntapalli Gram Panchayat, Tadipatri (M), Anantapuramu District-515411, Andhra Pradesh run by Sri Siddartha Educational Society, Tadipatri (M), Anantapuramu District-515411, Andhra Pradesh with an order for Continuation of recognition for B.Ed. programme for two-year duration with annual intake of 1 basic unit of 50 students subject to fulfillment of the following conditions:
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 12. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for

information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **14**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
