WHEREAS, the recognition was granted to the institution K.M.M College of Education, Ramireddipalli, Narasingapuram, Chandragiri Mandal, Tirupathi, Andhra Pradesh-517102 run by K.M.M Social and Educational Development Society, Tirupati, Andhra Pradesh vide order No. F.SRO/NCTE/B.Ed./2006-2007/6144 on 09.07.2007 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 19.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.04.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.
- AND WHEREAS, the SRC in its 363rd meeting held on 17th 19th September, 2018 3. considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 16.10.2018. The institution has submitted reply on 24.10.2018.
- AND WHEREAS, the SRC in its 395th Meeting held on 25th & 26th February, 2021 4. considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 15.03.2021. The institution has submitted reply on 01.04.2021.
- AND WHEREAS, the SRC in 400th Meeting held on 13th & 14th July, 2021 considered 5. the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC a withdrawal order no. F.SRO/NCTE/APS07144/B.Ed./AP/2021/127879-7886 dated 29.07.2021 was issued to the institution.
- AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an 6. Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-225/E-193150/2021 Appeal/20th Meeting, 2021 APPLSRC202114082 dt. 04.10.2021 appeal remand back the Order appealed against. The institution has submitted reply on 09.10.2021.
- AND WHEREAS, the SRC in its 406th Meeting held on 19th January 2022 considered the matter and decided as follows: -

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution K.M.M. College of Education, Survey No. 58-1 & 58-2, Ramireddi Palle, Narasingapuram, Chandragiri Mandal, Tirupathi-517102, Andhra Pradesh for B.Ed. programme for 2 basic units of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e., K.M.M. College of Education, Survey No. 58-1 & 58-2, Ramireddi Palle, Narasingapuram, Chandragiri Mandal, Tirupathi, Andhra Pradesh run by K.M.M Social and Educational Development Society, Tirupati, Andhra Pradesh-517102 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
 - V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
 - 9. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
 - 10. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
 - 11. - i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.
