ORDER

WHEREAS, the recognition was granted to the institution namely **Sri Kshana Mukteswara College of Education, Invali, Mukteswaram – 533211, East Godavari District, Andhra Pradesh** vide SRC (NCTE) order no. F.SRO/NCTE/2001-2002/8212 dated 15.10.2001 for conducting B.Ed. course of one-year duration with an annual intake of 120 students from the academic session 2001-2002.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 22.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 12.02.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 327th meeting held on 19th – 20th January, 2017 considered the matter and decided to issue reduction order. Accordingly, as per the decision of SRC reduction intake order was issued to the institution on 23.02.2017.

4. **AND WHEREAS**, after long deliberation the SRC final considered the cases of the institution in its 395th meeting held on 25th – 26th February, 2021 considered the matter and decided as under;

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Sri Kshana Mukteswara College of Education, Mukteswaram 533211, East Godavari District, Andhra Pradesh for B.Ed programme for 1 basic unit of 50 students.

5. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Sri Kshana Mukteswara College of Education, Sy.No. 230, Inavalli, Mukteswaram 533211, East Godavari District, Andhra Pradesh** run by **Sri Y.V.S & Sri B.R.M Memorial Educational Society, Inavilli (V) Mukteswaram, Inavalli Mandal, E.G. District, Andhra Pradesh-533211** for continuation of recognition for B.Ed course of two years duration with an intake of 50 students (1 basic unit) of subject to fulfillment of the following conditions:-



10. The institution shall make available the list of students admitted on its official website.

11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
