## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, Panchasheela College of Education, No. 7/1376, Korapadu road, Proddatur Mandal, Kadapa District-516360, Andhra Pradesh run Panchasheela Educational Society, Kadapa district, Andhra Pradesh vide SRC order F.SRO/NCTE/B.Ed/2007-2008/9905 dt. 27.08.2007 for conducting (B.Ed.) course of one-year duration from the academic session 2007-08 with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 20.01.2015. A revised provisional recognition order was issued to the institution on 29.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 (One basic unit) from the academic session 2015-16.
- 3. AND WHEREAS, a shifting order was issued to the institution on 05.04.2016 at its new premises i.e. Kodanda Ramaiah Memorial College of D.Ed. PlotNo. 528, 529, Ring Road, Kottapalli Village & Post, Proddatur Taluk & City, Kadapa District-516360, Andhra Pradesh.
- 4. AND WHEREAS, The SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC.
- 5. AND WHEREAS, a First Show Cause Notice was issued on 26.11.2019. The institutions vide letter dated 14.11.2020 submitted reply to the First Show Cause Notice. The institution vide latter dated 13.01.2016 has submitted fee of Rs 1.5Lakh for inspection for shifting of premises.
- 6. AND WHEREAS, the SRC its 387<sup>th</sup> meeting held on 24<sup>th</sup> & 25<sup>th</sup> August, 2020 the committee considered the matter and decided as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 14.11.2020 and found the following deficiencies: -

1. The institution has submitted notarized copy of building plan but not approved by competent authority. The institution is required to submit original blue-prints of Building Plan duly approved by the competent authority.

2. The institution has submitted notarized copy of site plan but not approved by competent authority. The institution is required to submit site plan duly approved

by the competent authority.

3. The institution has submitted photocopy of Staff list approved by the Registrar Yogi Vemana University consisting of one principal & Eight Lecturer, one work experience teacher and one Liberian submitted vide date 08.12.2015.

(i) The institution has submitted staff one principal & Eight Lecturer, one work experience teacher and one Liberian against the requirement of 1+15 for B.Ed. two basic units as per NCTE Regulations, 2014.

(ii) The institution is required to submit latest Staff List separately for each course being run by the institution duly approved by the Registrar, affiliating university.

- 4. The institution has not submitted Form "A" issued by the Branch Manager with the original copy of FDRs in favor of NCTE. The institution is required to submit Form A issued by the nationalized bank for maintain Endowment and Reserve Fund 7+5 Lakh as per NCTE Regulations in Joint account with RD, SRC, NCTE.
- 5. The institution has submitted notarize copy of affidavit but survey No., total land and built up area not mentioned.

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice.

- 7. AND WHEREAS, a Final Show Cause Notice was issued to the institution on 02.09.2020. The institution did not submit any reply of Final Show Cause Notice till date.
- **8. AND WHEREAS,** the matter was further considered by the SRC in its 394<sup>th</sup> meeting held on January 27-28, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The Committee noted that the institution has not submitted any reply in response to the Final Show Cause Notice issued to the institution on 02.09.2020.

Hence, the Committee decided to withdraw the recognition granted to Panchasheela College of Education, No. 7/1376, Korapadu road, Proddatur Mandal, Kadapa District-516360, Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-2021 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 9. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Panchasheela College of Education, No. 7/1376, Korapadu road, Proddatur Mandal, Kadapa District-516360, Andhra Pradesh run by Panchasheela Educational Society, Kadapa district, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. academic session 2020-2021 onwards.
- 10. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

11. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order.
