WHEREAS, the recognition was granted to the institution namely Adarsha college of Education, Adarsha Hills, Narayampet, Mahabubnagar-509210, Telangana run Adarsha Educational Society, H.No. 1-5-30/4, Adarsha Hills, Narayanpet-509210, Mahbubnagar, Telangana. The SRC vide order F.SRO/NCTE/APS07308/B.Ed/2007-2008/13062 dt. 16.10.2007 for conducting Secondary (B.Ed.) course of one-year duration from the academic session 2007-08 with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 27.01.2015. A revised provisional recognition order was issued to the institution on 29.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice issued on 05.02.2019. The institution has not submitted reply to the Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a First Show Cause Notice issued on 14.11.2019. The institution submitted vide letter received on 27.11.2019 its reply to the First Show Cause Notice.
- 5. AND WHEREAS, the matter was further considered by the SRC in its 394th meeting held on January 27-28, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution on 09.07.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

1. The institution has submitted land Use Certificate but land area & Survey No. are not mentioned.

2. The institution has submitted photocopy of building plan but the same is not approved by competent authority & multipurpose hall size is not mentioned.

3. The institution has submitted photocopy of BCC but the built up area are different in BCC & building plan.

4. The institution has submitted a faculty list which is not approved by the Affiliating body. Some deficiencies are: -

A letter regarding approval of faculty issued by the affiliating body has not submitted by the institution.

ii. The institution has not appointed performing arts faculty.

- 5. The institution has not submitted a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.
- 6. The institution has not submitted affidavit regarding land area & built up area.

Hence, the Committee decided to withdraw the recognition granted to Adarsha college of Education, Adarsha Hills, Narayampet, Mahabubnagar-509210, Telangana for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Adarsha college of Education, Adarsha Hills, Narayampet, Mahabubnagar-509210, Telangana run by Adarsha Educational Society, H.No. 1-5-30/4, Adarsha Hills, Narayampet-509210, Mahbubnagar, Telangana for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website

www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
