WHEREAS, the recognition was granted to the institution namely Sri Malayalaswamy College of Education, Sree Krishna Geetha Ashramam, Gandhi Road, Proddature, Kadapa-516360, Andhra Pradesh run Sri Malayalaswamy Educational Trust, Kadapa District, Andhra Pradesh. The SRC vide order F.SRO/NCTE/B.Ed/2007-2008/8401 dt. 20 08 2007 for conducting Secondary(B.Ed.) course of one-year duration from the academic session 2007-2008 with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 27.01.2015. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the institution submitted written representation on 29.05.2015 requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. A corrigendum dated 26.06.2015 was issued to the institution permitting the institution to have <u>one basic unit of 50 students</u>.
- **4. AND WHEREAS**, on 30.07.2015, a letter dated 30.07.2015 is received by the this office from the principal, Malayalaswamy College of Education Sree Krishna Geetha Ashramam, Gandhi Road, Proddature, Kadapa-516360, Andhra Pradesh.
- 5. AND WHEREAS, SRC in its 320th meeting held on 19th to 20th September 2016, decided as under:-
 - 1. This is a RPRO case of B.Ed (1 unit)
 - 2. There is, therefore, no need to inspect.
 - 3. Land documents not given.
 - 4. BP not approved0.
 - 5. BCC is not in the format.
 - 6. EC not given.
 - 7. LUC is not duly approved.
 - 8. FDRs not given.
 - 9. Society Registration not given.
 - 10. Faculty list id defective
 - Principal has no Ph.D
 - Asst. Prof (Arts) and Asst. Prof (F.A) not there

11. Issue SCN accordingly.

Accordingly, a Show Cause Notice was issued to the institution on 24.10.2016.

- 6. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue Final SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Final Show Cause Notice was issued to the institution on 29.11.2019. The institution submitted its reply to the Final Show Cause Notice vide letter dated 18.12.2019.
- 7. AND WHEREAS, the matter was further considered by the SRC in its 394th meeting held on January 27-28, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution on 18.12.2019 in respect to the Final Show Cause Notice and found the following deficiencies: -

- 1. The institution has submitted notarized copy Land Document in the Name of an individual person.
 - (i) Purchaser: Name Yerikalaiah, adopted son Name Chinna Venkata Subbaiah
 - 1. The institution has submitted notarized copy Land Document in the Name of an individual person.
- (i) Purchaser: Name Yerikalaiah, adopted son Name Chinna Venkata Subbaiah,
 - 2. The institution has submitted Notarized copy of Building Plan and Site Plan approving authority seal in regional language.
 - (i) Area of multipurpose hall not sufficient as per NCRE Regulation.
 - 3. The institution has submitted photocopy of staff list vide letter dated 31.07.2017.
- (i) The institution has not submitted the appointment of staff in 01 Performing Arts and 01 Fine Arts.
 - 4. The institution has submitted Form "A" issued by the Branch Manager in favor of NCTE with photocopy of Matured FDRs.
 - 5. The institution has submitted Domain name of the website being run by the institution.
 - 6. The institution has not submitted an Affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details
- (i) Details of land & building available at the time of recognition with the Institution.
- (ii) Details of land & building now available with the Institution.
- (iii) Status of Management at the time of recognition and its present status.

Hence, the Committee decided to withdraw the recognition granted to Sri Malayalaswamy College of Education, Sree Krishna Geetha Ashramam, Gandhi Road, Proddature, Kadapa-516360, Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-2021 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sri Malayalaswamy College of Education, Sree Krishna Geetha Ashramam, Gandhi Road, Proddature, Kadapa-516360, Andhra Pradesh run by Sri Malayalaswamy Educational Trust, Kadapa District, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. academic session 2020-2021 onwards.
- 9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
