WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, Sri A.R.K.R. Memorial B.Ed. College, No. 12-13, Near G.N.T. Road, Sullurpet, Nellore District – 524121, Andhra Pradesh run Siddharth Educational Society, Nellore District – 524121, Andhra Pradesh. The SRC vide order F.SRO/NCTE/B.Ed/2007-2008/17243 dt. 21.01.2008 for conducting (B.Ed.) course of one-year duration from the academic session 2007-08 with an annual intake of 100 students.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 22.01.2015. A revised provisional recognition order was issued to the institution on 06.05.2020 for conducting B.Ed. course of two years duration with an annual intake of 50 (one basic unit) from the academic session 2015-16.

3. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance of conditions stipulated in RPRO. Accordingly, as per the decision of SRC show cause notice was issued to the institution on 31.01.2019. The institution vide letter dated 20.02.2019 submitted reply to the show cause notice.

4. AND WHEREAS, the SRC in its 374th meeting held on 09th – 10th April, 2019 considered the matter decided to issue show cause notice. Accordingly, a show cause notice was issued to the institution on 22.04.2019.

5. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a Final Show Cause Notice issued on 20.11.2019. The institution submitted vide letter received on 23.12.2019 its reply to the Final Show Cause Notice.

6. AND WHEREAS, the matter was further considered by the SRC in its 394th meeting held on January 27-28, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution on 23.12.2019 in respect to the Final Show Cause Notice and found the following deficiencies: -

1. The institution has not submitted certified English Translate copy land documents.
2. The institution has not submitted land use certificate duly approved by the competent authority.
3. The institution has submitted photocopy of NEC which is in regional language.
4. *The institution has submitted photocopy of Building Plan not mentioned built-up area, institution name, site area, multipurpose hall area & not approved by competent authority.*
5. The institution has submitted photocopy of BCC but not a prescribe format.
6. *The institution has submitted Site Plan but not approved by the competent authority.*
7. The institution has submitted a faculty list which is not approved by the Affiliating body. Some deficiencies are: -
 - i. A letter regarding approval of faculty issued by the affiliating body has not submitted by the institution.
 - ii. The institution has not appointed Physical Education, Performing Arts & Fine Arts faculty.
8. The institution has not submitted a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.

Hence, the Committee decided to **withdraw the recognition** granted to **Sri A.R.K.R. Memorial B.Ed. College, No. 12-13, Near G.N.T. Road, Sullurpet, Nellore District – 524121, Andhra Pradesh** for conducting **B.Ed** course w.e.f. the 2020-2021 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Sri A.R.K.R. Memorial B.Ed. College, No. 12-13, Near G.N.T. Road, Sullurpet, Nellore District – 524121, Andhra Pradesh** run by **Siddharth Educational Society, Nellore District – 524121, Andhra Pradesh** for conducting **B.Ed. course** of two years duration with an annual intake of **50 students** w.e.f. academic session 2020-2021 onwards.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or

University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
