WHEREAS, the recognition was granted to the institution namely Mohan College of Education, D.No. 10-477, Eswar Nagar, 3 APSP Camp (post) Kakinada Rural, East Godavari District 533005. Andhra Pradesh run by Mohan Education Society, East Godavari District-533005, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2008/5120 dt 22.09.2008 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. 08.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the institution submitted written representation on 17.08.2015 requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course.

AND WHEREAS, a corrigendum dated 21.07.2017 was issued to the institution permitting the institution to have one basic unit of 50 students.

AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. A First Show Cause Notice was issued to the institution on 10.12.2019. The institution has submitted a letter received on 31.12.2019 regarding submission of explanation for First Show Cause Notice.

AND WHEREAS, the SRC in its 394th Meeting held on 27th - 28th January, 2021 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the management by its letter dt 31.12.2019 by withdrawing the recognition granted to Mohan College of Education, D.No. 10-477, Eswarnagar, Kakinada, East Godavari-533005, Andhra Pradesh for conducting B.Ed course under clause 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

(c) Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Mohan College of Education, D.No. 10-477, Eswarnagar, Kakinada, East Godavari-533005, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) w.e.f. academic session 2020-2021.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
