WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, Mother College of Education D.Ed Plot/Khasara No. 541/5, Street No. 0, Darsi Village and Post Office, Darsi Taluk and Town/City Prakasam District-523247, Andhra Pradesh run Mother Educational Development Society, Plot No. 4-1498, Podili Road, Darsi Village and Post, Darsi Taluk & City, Prakasam District-523247, Andhra Pradesh. The SRC vide order F.SRO/ F.SRO/ SRCAPP2596/D.El.Ed/AP/2016/83523 dated 05.04.2016 for conducting (D.El.Ed.) course of two-year duration with two units of 50 students each from the academic session 2016-17.

2. AND WHEREAS, A letter No. RC. No. 359/A/SCERT/2019 dated 29.06.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for de-recognition order in respect of 188 Pvt. D.El.Ed Colleges in A.P. since the said managements of Pvt. D.El.Ed Colleges have made admission into the D.El.Ed Course during academic year 2018-19 on their own in violation of Government orders.

3. AND WHEREAS, The matter was considered by SRC in its 386th meeting held on 23rd-24th July, 2020 and decided to issue Show Cause Notice as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee perused the letter No. RC. No. 359/A/SCERT/2019 dated 29.6.2020 received from Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for de-recognition order in respect of 188 Pvt. D.El.Ed. Colleges in A.P. since the said managements of Pvt. D.El.Ed. colleges have made admission into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders.

Hence, the Committee decided to issue Show Cause Notice asking them to submit following documents/information:-

1. The institution is required to explain about the observations made by the School Education Department, Govt. of Andhra Pradesh vide letter No. RC. No. 359/A/SCERT/2019 dated 29.6.2020
2. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional

Language the institution is also required to submit notarised copy of English version of land documents)

3. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.
4. The institution has not submitted a copy of Non-Encumbrance Certificate issued by the Competent Authority. The institution is required to submit an attested/notarised copy of Non - Encumbrance Certificate issued by the Competent Authority.
5. The institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
6. An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
7. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
8. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. ***(In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)***
9. The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alongwith a copy of the FDRs
10. Details of Teacher Education programme (s) being run by the Institution in the same campus

14. The institution shall be required to submit an Affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details

- (i) Details of land & building available at the time of recognition with the Institution.
- (ii) Details of land & building now available with the Institution.
- (iii) Status of Management at the time of recognition and its present status.

In case of change of land & building or the Management at the time of recognition and thereafter the institution is required to specify the reason thereof with approval of the SRC, NCTE.

Therefore, the Committee decided to issue **Show Cause Notice u/s 17 of NCTE Act, 1993** before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of **Show Cause Notice**.

4. **AND WHEREAS**, as per the decision of SRC, a Show Cause Notice was issued to the institution on **21.08.2020**. The institution did not submit any reply of Show Cause Notice till date.

5. **AND WHEREAS**, the matter was further considered by the SRC in its 394th meeting held on January 27-28, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The Committee noted that the institution has not submitted any reply in response to the Show Cause Notice issued to the institution on 21.08.2020.
2. Further, the Committee also perused the letter received from the Director, School Education, Govt. of Andhra Pradesh with a request to withdraw the recognition to this institution as they committed irregularities in the process of admission.

Hence, the Committee decided to **withdraw the recognition** granted to **Mother College of Education D.Ed Plot/Khasara No. 541/5, Street No. 0, Darsi Village and Post Office, Darsi Taluk and Town/City Prakasam District-523247, Andhra Pradesh** for conducting **D.El.Ed** course w.e.f. the 2020-2021 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Mother College of Education D.Ed Plot/Khasara No. 541/5, Street No. 0, Darsi Village and Post Office, Darsi Taluk and Town/City Prakasam District-523247, Andhra Pradesh** run by **Mother Educational Development Society, Plot No. 4-1498, Podili Road, Darsi Village and Post, Darsi Taluk & City, Prakasam District-523247, Andhra Pradesh** for conducting



D.El.Ed. course of two years duration with an annual intake of **100** students w.e.f. the next academic session i.e. 2020-2021 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
