F.SRO/NCTE/SRCAPP2866/M.Ed./TS/2016-2017/82927 dt. 03.03.2016 for conducting M.Ed programme of two years duration with an annual intake of 50 students (1 unit) from the academic session 2016-2017.

AND WHEREAS The institution vide letter dated 17.12.2019 submitted written representation for closing of the institution The SRC in its 394th meeting held during 27th – 28th January, 2021 considered the matter and decided as under:

The Committee agreed to close down the institution as requested by the management by its letter dt 17.12.2019 by withdrawing the recognition granted to St. Francis College of Education, No.253, Gandhinagar, Janagaon Road Village, Suryapet Post & Taluk, Nalgonda District-508213, Telangana for conducting M.Ed course under clause 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of St. Francis College of Education, No.253, Gandhinagar, Janagaon Road Village, Suryapet Post & Taluk, Nalgonda District-508213, Telangana run by St. Francis Educational Society, No. B-1, M.S. Apartments CPL Road, Amberpet Village & Post, Hyderabad Taluk, Hyderabad District, Telangana for conducting M.Ed. programme of two year duration with an annual intake of 50 students (1 unit) w.e.f the academic session 2020-2021.
